# INSTRUCTIONS FOR FILING 24-HOUR REPORTS OF EXPENDITURES BY MUNICIPAL, DISTRICT AND COUNTY COMMITTEES 2009 HOUSE DISTRICT 89 SPECIAL ELECTION

## What expenditures should be reported?

Municipal, district and county party committees must disclose any expenditure of \$500 or more made for the purposes of influencing the House District 89 Special Election during the last thirteen (13) days before the election. The 24-Hour reporting period for this election is:

**January 21, 2009 – February 2, 2009** 

### When this report must be filed?

The report must be filed within 24 hours of the expenditure, including Saturdays and Sundays.

#### Facsimile transmission

A campaign finance report may be filed provisionally by faxing a properly signed report to the Ethics Commission by the deadline, as long as the original of the same report is received by the Commission within five (5) calendar days thereafter.

#### **IMPORTANT REMINDERS**

The information contained in this report must also be included on the appropriate schedule of the next regularly scheduled campaign finance report.

If an expenditure is disclosed in an independent expenditure report, it is not necessary to file a separate 24-hour report for the same expenditure.
