### INTRODUCTION

This document is a Consent Agreement regarding Marie C. Cashmere's application for licensure by endorsement to practice as a licensed practical nurse in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(B) and 10 M.R.S.A. Section 8003(5)(A-1)(4). The parties to this Consent Agreement are: Marie C. Cashmere, the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine.

Ms. Cashmere appeared before the Board on April 12, 1990 requesting licensure by endorsement upon successfully passing the NCLEX-PN. Refer to previous Consent Agreement of April 5, 1990 for details.

### FINDINGS OF FACT

As a result of the informal conference, the Board incorporated by reference the Findings of Fact contained in the original Consent Agreement of April 5, 1990.

### COVENANTS

Based on the above Findings of Fact, the Board voted to incorporate by reference the Covenants contained in the original Consent Agreement of April 5, 1990 allowing Ms. Cashmere to sit for the April examination and agreed to the following additional terms and conditions for licensure upon successfully passing the examination:

7. Ms. Cashmere shall return to the Board in September of 1990 and, prior to that meeting, provide a progress report to the Board from her psychiatrist, Dr. Anderson.

### INTRODUCTION

This document is a Consent Agreement regarding Marie C. Cashmere's application for license by endorsement to practice as a licensed practical nurse in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(C) (1988). The parties to this Consent Agreement are: Marie C. Cashmere, the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine.

By letter dated September 25, 1989, Marie Cashmere was advised by the Board that it had denied her application for license endorsement. By letter to the Board dated October 19, 1989, Marie Cashmere requested the opportunity to appear before the Board and appeal the decision. By letter dated November 28, 1989, Marie Cashmere was advised by the Board that it would invite her to appear before it at an informal conference pursuant to 32 M.R.S.A. Section 2105-A(1-A). At the informal conference, held on December 14, 1989, Ms. Cashmere was present without counsel.

### FINDINGS OF FACT

As a result of the informal conference, the Board made the following findings of fact:

1. By letter dated December 12, 1989, from Marie Cashmere's psychiatrist, Dr. David E. Anderson, it was his opinion that Ms. Cashmere is capable of working as a practical nurse.
2. Ms. Cashmere admits to the diversion of 6 Dalmane tablets.
3. Ms. Cashmere has no support system.
4. Ms. Cashmere is undergoing treatment for physical and psychiatric conditions.

5. Ms. Cashmere plans to continue seeing her psychiatrist.
6. Ms. Cashmere is making continued attempts to avoid drugs.

COVENANTS

Based on the above findings of fact, the Board voted to allow Ms. Cashmere to sit for the April examination and agreed to the following terms and conditions for licensure upon successfully passing the examination:

1. Ms. Cashmere shall continue with her psychiatric care.
2. Ms. Cashmere shall establish a self-help support group system pursuant to her psychiatrist's recommendations.
3. Ms. Cashmere shall return to the Board on April 12, 1990 to provide a progress report on her support group system and a report from her psychiatrist. The reports shall be provided to the Board prior to April 12.
4. Ms. Cashmere shall provide a patient drug profile to the Board prior to the April 12, 1990 meeting.
5. Ms. Cashmere hereby waives all claims of confidentiality and privilege she may have regarding reports to be submitted to the Board in accordance with this Consent Agreement.
6. Ms. Cashmere understands and accepts that the Board may condition any license given to her at, or subsequent to, the April 12, 1990 meeting.
