CONSENT AGREEMENT
REGARDING PROBATIONARY
STATUS OF LICENSURE

INTRODUCTION

This document is a Consent Agreement regarding Donna M. Chamoff's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. sub-section 2105-A(1-A)(1988). The parties to this Consent Agreement are: Donna M. Chamoff, R.N., the Maine State Board of Nursing ("the Board") and the Department of Attorney General, State of Maine.

Following an informal conference held on December 17, 1987, Ms. Chamoff agreed to voluntarily surrender her license for a two-year period pursuant to a Consent Agreement entered into with the Board and the Department of the Attorney General. By letter dated May 23, 1989, Ms. Chamoff requested early reinstatement of her license. The Board met with Ms. Chamoff at its regular meeting on June 22, 1989 to discuss her request for reinstatement.

FINDINGS OF FACT

As a result of the meeting with Ms. Chamoff, the Board made the following findings of fact:

1. Ms. Chamoff has maintained continuous sobriety for approximately two years.
2. Ms. Chamoff has complied with the conditions of the Consent Agreement entered into following the informal conference on December 17, 1987.
3. Ms. Chamoff has established a good support system.
4. Ms. Chamoff continues to be active in her recovery.

COVENANTS

Based on the above findings of fact, the Board voted to reinstate Ms. Chamoff's license on a two-year probationary status subject to the following conditions:

1. Ms. Chamoff shall maintain sobriety at all times.
2. Ms. Chamoff shall continue her substance abuse counseling program as recommended by her counselor.
3. Ms. Chamoff shall arrange for her substance abuse counselor to submit quarterly reports to the Board regarding her progress, including a final report when counseling is terminated upon the advice of her counselor.
4. Upon employment as a nurse, Ms. Chamoff shall provide her nurse employer a copy of this Consent Agreement.
5. Ms. Chamoff shall arrange for her nurse employer to submit quarterly reports to the Board regarding her performance.
6. Ms. Chamoff hereby waives all claims of confidentiality and privilege she may have regarding reports to be submitted to the Board in accordance with this Consent Agreement.
7. Ms. Chamoff understands and agrees that violation of this Consent Agreement may result in suspension or revocation of her license to practice professional nursing.
8. Ms. Chamoff understands and agrees that at the end of the probationary period the Board may, in its discretion, extend the term and conditions of her probation.
