This is a Consent Agreement regarding Calvin Dube's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. § 2105-A(1-A)(B) and 10 M.R.S.A. § 8003(5)(B). The parties to this Consent Agreement are Calvin E. Dube, the Maine State Board of Nursing ('Board'') and the Department of Attorney General, State of Maine.

FINDINGS OF FACT

- 1. Calvin Dube, while employed as a registered professional nurse at St. Mary's Regional Medical Center in 1993, engaged in sexual acts with a 15 year old patient receiving treatment at the hospital for a psychiatric diagnosis.
- 2. Calvin Dube engaged in sexual activity with the 15 year old patient over a five-week period from approximately March 26, 1993 through May 5, 1993.
- 3. Calvin Dube has been a registered professional nurse since 1978 and had been an employee with a good record at St. Mary's Regional Medical Center for six years.
- 4. On June 15, 1994, Calvin Dube pled guilty to two counts of gross sexual assault.
- 5. Calvin Dube was sentenced to prison for five years with all but three years suspended, with a period of probation of four years.

AGREEMENT

- 1. Calvin Dube's conduct constitutes grounds for discipline pursuant to 32 M.P.S.A. § 2105-A(2)(E)(1), (F) and (G).
- 2. The parties agree that Calvin Dube's license to practice professional nursing in the State of Maine is hereby REVOKED.
- 3. Calvin Dube understands that this document is a Consent Agreement which revokes his license to practice nursing in the State of Maine. Mr. Dube understands that he does not have to execute this Consent Agreement and that he has a right to consult with an attorney before entering into this Consent Agreement. Mr. Dube affirms that he executes this Consent Agreement of his own free will.
