CONSENT AGREEMENT REGARDING LICENSURE INCLUDING REPRIMAND

## INTRODUCTION

This document is a Consent Agreement regarding Susanna R. King's license to practice professional nursing in the State of Maine, entered into pursuant to 32 M.R.S.A. Section 2105-A(1-A)(B) and 10 M.R.S.A. Section 8003(5)(B). The parties to this Consent Agreement are: Susanna R. King, R.N., the Maine State Board of Nursing ("Board") and the Department of Attorney General, State of Maine.

Ms. King's license lapsed in 1989, 1990, and 1991. In each of those years it was reinstated upon Ms. King's late application. Ms. King's renewal application was received on time in 1992 and the license remained in effect without a lapse. The following day it was returned to her with the request that she provide an explanation and information regarding her employment history. She has remained in a lapsed status since that time.

Ms. King is now requesting that the Board reinstate her license. On February 9, 1995 she met with the Board. At that meeting the Board voted to offer a Consent Agreement as follows:

## COVENANTS

Ms. King's license to practice professional nursing in the State of Maine is hereby reinstated with the following conditions:

- 1. Ms. King shall pay a fine in the amount of \$1,000.00 to the Board. All parties acknowledge that Ms. King has made payment of that fine.
- 2. Ms. King shall be, and she hereby is, REPRIMANDED for her conduct in this matter, and she is advised to conform her future conduct accordingly.
- 3. The Board agrees to take no further disciplinary action upon these facts.
- 4. Ms. King understands that this document is a Consent Agreement which affects her rights to practice nursing in Maine. This Consent Agreement may be amended only in writing, signed by all the parties. Ms. King understands that she does not have to execute this Consent Agreement

and that she has the right to consult with an attorney before entering this Consent Agreement. Ms. King affirms that she executes this Consent Agreement of her own free will.
