

Dear Sirs:

Vernetta Sencabaugh, entity number holder of license or certificate of authority number P011188, Licensed Practical Nurse, issued by the Maine Board of Nursing, was notified by certified mail on January 28, 2010, of the State Tax Assessor's determination to prevent renewal, reissuance or other extension of the above license or certificate of authority.

Mr/Ms Sencabaugh has exhausted the steps of appeal permitted by 36 M.R.S.A. §151 and the determination is now final. You are, therefore, hereby requested, pursuant to 36 M.R.S.A. §175 and Maine Bar Rule 6(b)(2), to refuse to reissue, renew or otherwise extend the certificate of authority until such time as the State Tax Assessor issues a certificate of good standing.

The basis for this action is the taxpayer's failure to file and/or failure to pay State of Maine tax obligations.
