INTRODUCTION

This document is a Consent Agreement regarding Victoria C. Volman's license to practice registered professional nursing in the State of Maine. The parties enter into this Agreement pursuant to 10 M.R.S.A. § 8003(5)(A-1)(1), § 8003(5)(B) and 32 M.R.S.A. § 2105-A(1-A)(A). The parties to this Consent Agreement are Victoria C. Volman ("Licensee"), Maine State Board of Nursing ("Board") and the Office of the Attorney General, State of Maine. An informal conference was held on December 10, 2003. The parties reached this Agreement on the basis of information submitted by Presque Isle Nursing Home by letter dated February 25, 2003.

FACTS

1. Victoria C. Volman has been a registered professional nurse licensed to practice in Maine since 1999.
2. Victoria C. Volman admits that she failed to follow medication administration policies and document the medication Rocephin to a resident, which compromised the safety of the resident. Ms. Volman was terminated from Presque Isle Nursing Home on February 3, 2003.
3. Victoria C. Volman admits that she had conversations with two of the residents at Presque Isle Nursing Home subsequent to her termination on February 25, 2003 and improperly involved these residents in the issues relative to her termination.

AGREEMENT

4. Victoria C. Volman agrees and understands that her conduct constitutes in the above stated facts are grounds for discipline under Title 32 M.R.S.A. § 2105-A(2)(F), (2)(H) and Chapter 4.1.A.6., 4.3.F. and 4.3.U. of the Rules and Regulations of the Maine State Board of Nursing. Victoria C. Volman is hereby **REPRIMANDED** for unprofessional conduct and for failing to take appropriate action or follow policies and procedures in a practice situation designed to safeguard the patient and failing to recognize appropriate professional-patient boundaries.

5. Victoria C. Volman understands that this Consent Agreement imposes discipline regarding her license to practice professional nursing in the State of Maine. Ms. Volman understands that she does not have to execute this Consent Agreement and that she has the right to consult with an attorney before entering into this Consent Agreement.
6. Victoria C. Volman affirms that she executes this Consent Agreement of her own free will.
7. Modification of this Consent Agreement must be in writing and signed by all the parties.
8. This Consent Agreement is not subject to review or appeal by the Licensee, but may be enforced by an action in the Superior Court.
9. This Consent Agreement becomes effective upon the date of the last necessary signature below.

I, VICTORIA C. VOLMAN, R.N., HAVE READ AND UNDERSTAND THE FOREGOING CONSENT AGREEMENT. I UNDERSTAND THAT BY SIGNING IT, I WAIVE CERTAIN RIGHTS. I SIGN IT VOLUNTARILY, WITHOUT ANY THREAT OR PROMISE. I UNDERSTAND THAT THIS CONSENT AGREEMENT CONTAINS THE ENTIRE AGREEMENT AND THERE IS NO OTHER AGREEMENT OF ANY KIND.


