Long Creek Youth Development Center Visit Information

Effective 7/13/2020

Non-contact visitation resumes the week of July 13, 2020 across MDOC facilities. Please note that visitation schedules can change abruptly based on the current COVID-19 climate.

<u>Visitors to the Long Creek Youth Development Center will be required to abide by the following</u> restrictions:

Anyone unable or unwilling to adhere to the following requirements may be turned away.

Face Coverings

- Visitors will be required to wear a face covering.
 - o If you do not have a face covering, one will be provided to you at no cost.
 - o Children 5 years of age and under will not be required to wear a face covering.
 - o Please contact the JPM if you have concerns about wearing a face covering.

Health and Travel Screenings

- Visitors will be screened upon entry, this includes a questionnaire and temperature check.
 - O Visitors may be asked to leave if their temperature indicates a fever, and/or if their answers on the questionnaire indicate a COVID-19 concern.
- At this time, visitors will only be permitted if they are residents of Maine, New Hampshire, Vermont,
 New York, Connecticut, or New Jersey.
 - Visitors will be asked to show valid identification.

Visit Details

- Visits will be limited to two persons from the same household.
- Visits are non-contact, you will be on separate sides of a glass partition.
- You must always remain 6 feet away, no touching.
- No items may be brought in, that includes food, drinks, personal belongings. Please leave these items in your vehicle.
 - o Lockers are not available, please leave your belongings in your vehicle.

• Visitation at Bearings will take place outside, you will be required to be at least 6 ft apart and wear a facial covering.

To Schedule a Visit

- To schedule a visit, please contact the juvenile's Juvenile Program Manager or Psychiatric Social Worker. They will ensure a space will be reserved for you.
- If you have not done so, please fill out and submit the visitor application prior to visiting.
- Visitors for detained youth may bring the application with them on the first visit.
- Video visitation will continue to be available for those unable to come for in-person visits.
