WHO MAY USE THIS SUPPLEMENT?

You must submit this supplement if you are proposing an activity or use which requires permit approval by the Maine Land Use Planning Commission ("Commission" or "LUPC"), you wish to authorize an agent to act on your behalf in seeking such permit approval, and your application materials have not included a similar agent authorization. **Note: most application forms include an agent authorization section.**

WHERE CAN I GET HELP TO COMPLETE THIS FORM?

Call the LUPC office that serves your area and ask to speak to or meet with one of our regional representatives (see below for office locations and contact information).
