I am submitting again another public comment regarding the proposed Dallas Plantation telecommunication tower this time in response to the revised plan.

It seems remarkable to me that, after all this time, a new option has been offered, one that is substantially modified from the previous model. As you know, this new tower has been reduced in size by over one third compared to previous structure. In addition, lighting modifications have been made.

One immediately asks why this smaller version was not offered at first. And if the plan has been altered now, why could not there be further modifications? I think this manipulation not only throws into doubt the reliability of the proposal, but also the contentions that no other site is possible and that the effects on neighboring properties would be minimal.

As I wrote previously, the question is not whether improved telecommunication will benefit the region. The question is whether this structure is appropriate to meet the need.

I do not think so.
