On October 3, 2019, Department staff requested additional information from CMP concerning the Merrill Strip Alternative. On October 10, 2019 CMP responded to that request. I have reviewed the submission and CMP has provided all additional information which was requested. As specified in the 16th Procedural Order, the Parties will have 30 days from the date a notice is published in the newspapers to provide written testimony and evidence on the amendment. I have requested our administrative staff submit the notice to the newspapers. In addition, I have asked the Department's webmaster to put the information on our website. I have also asked our GIS person update the Google Earth map.

I will be leaving on vacation later this morning and won't return until October 21. I will notify the Parties of the closing date for submission of testimony and evidence upon my return, as it will depend on when the notice is published.
