Subject: Official notice of agency records

I. Background

A. Access Easement: There are general references in the record of this proceeding to conservation easements on lands in proximity to the project area – see, for example, testimony of Catherine B. Johnson of the NRCM at the evening session of the June 27, 2011, Bowers Wind Project public hearing. No person or agency, however, offered the written text of any specific conservation easement.

Notably, the Bureau of Parks and Lands, on behalf of the State of Maine, holds an Access Easement on lands in proximity to the project area, including lands that abut, for example, Pleasant, Junior, and Scraggly lakes. This Access Easement is attached to this order (note that the attachment includes the first page twice, demonstrating recording of the document at the registry of deeds in two separate counties).

While the attached Access Easement provides some substantive information possibly relevant to the review criteria applicable to wind energy development, it primarily provides background contextual information on the surrounding area.
