This can only be done by BPC staff or another Administrator within your company. If you do not already have these rights, please contact us at 207-287-2731 or pesticides@maine.gov

This module describes how a Company Administrator can apply for commercial licenses for employees (Master Applicator, Operator Applicator, Restricted Use Pesticide Dealer). Be sure the employee has passed the necessary exams before applying for a license.

### **License Exception**

If the applicant has or has had a license with the BPC (even if it expired or terminated), the following message will display.

Apply for License (APPLY-1263)

Your license application requires special processing. You will be contacted by BPC staff to complete the process.

To accommodate the new matching license/certification period, the license expiration date will be set to match the applicant's other license(s). The price will be set accordingly. You will need to reopen the application from My Worklist on the Company/Agency home page to make a payment and complete the process.

### Make a Payment

If the applicant does not have a license with the BPC, the payment screen will display and the license/certification period will be set to expire on 12/31 of the third year.

Enter payment information. If address associated with a credit card is a Post Office Box, enter the number first.

If you want an email receipt from the State of Maine, select the box next to Send Email Receipt.
