**I. DEPARTMENTAL**

**A. COMMISSIONER’S COMMENTS:** Acting Commissioner Aho reported the following:

LD 1: With the enactment of LD1, the Department is preparing to implement some of the rulemaking functions that will be conducted by the Office of the Commissioner. Currently, the Department is undergoing an analysis of rules to identify which venue the rule will fall into (Commissioner/Board). It is anticipated that both the Board and the Commissioner’s Office will likely have a heavy rulemaking schedule this fall.

Lead National Ambient Air Quality Standard: In 2009 Maine sought a designation of unclassifiable for the National Ambient Air Quality Standards for lead. EPA recently notified Governor LePage that it has made a preliminary decision to designate the entire State of Maine as unclassifiable/attainment for the 2008 Lead National Ambient Air Quality Standard.

- DEP will be analyzing selected filters collected from all Particulate Matter (PM10) sites in the state for lead levels and based on those results a final decision will be made concerning the future need to monitor for the lead ambient air quality standard.
- Final designations are anticipated by mid-October.

Maine Energy: A public meeting was held in Biddeford to receive comments on the draft air emission license for the Maine Energy waste to energy incinerator. Members of the public expressed concerns related to: (1) ongoing odor impacts, (2) potential health impacts from VOC’s and toxic air emissions. The Department will accept comments on the draft license until July 25, 2011. It is anticipated that a licensing decision will be available later this summer.

The Board voted (8-0-1-0) on a motion to approve the modified draft proposed Board Order as presented. The Board order denies the appeal submitted by Androscoggin River Alliance and the individually names residents and affirms the Commissioner decision for approval of the Phase 1 of a Four Season Resort and Casino in Oxford. The Board Order requires the licensee to submit additional documentation of financial capacity prior to any additional work at the site other than work related to testing for water supply. It also requires the licensee to complete testing for the water supply wells and submit the results to the Department staff for review and approval prior to September 14, 2011. No work other than site preparation and work related to testing for water supply may be done on the project site prior to Department review and approval of the water supply test results.

The vote was taken pursuant to 38 M.R.S. § 341-D(4), § 344(2-A), § 480-A et seq., § 481 et seq., and 06-096 CMR Chapter 2, Rules Concerning the Processing of Applications and other Administrative Matters, and Chapters 310, 335, 373, and 375.
