#### FINDINGS OF FACT

After review of the file and related materials submitted with regard to the above noted application, pursuant to Title 38, Maine Revised Statutes (M.R.S.) § 590 and 06-096 Code of Maine Rules (C.M.R.) ch. 115, the Maine Department of Environmental Protection (the Department) finds the following facts:

### I. Registration

#### A. Introduction

Industrial Connections & Solutions LLC (ICS) has requested the transfer of Air Emission License A-152-71-K-R/A from Industrial Connections & Solutions LLC, owned by General Electric Company (GE), to Industrial Connenctions & Sollutions LLC, owned by ABB Inc. (ABB) through a letter to the Department dated 07/13/2018.

Air Emission License A-152-71-K-R/A was issued to Industrial Connections & Solutions LLC on 09/26/2017. This license changed the name on the license from General Electric Company to Industrial Connections & Solutions LLC due to the establishment of a subsidiary of the same name. Since GE remained the parent company of the facility, the change was considered an administrative change of the legal entity name. The subsidiary has now been sold to ABB and will keep the same name (Industrial Connections and Solutions LLC).

ICS has also requested a minor revision to the license to correct the exhaust and control points for Line 2.

All rules, regulations, or statutes referenced in this air emission license refer to the amended version in effect as of the issued date of this license.

# B. Emission Equipment

The following equipment is addressed in this air emission license amendment:

#### C. Amendment Classification

This amendment will not increase emissions of any pollutant. Therefore, this amendment is determined to be a minor revision and has been processed as such.

### II. Best Practical Treatment (BPT)

# A. Amendment Description

ICS has requested that the exhaust and control points for Line 2 be updated. Air emission license A-152-71-K-R/A licenses Line 2 to exhaust to Stack #9 through Scrubber #4. This Minor Revision licenses Line 2 with the ability to concurrently exhaust to Stack #6 through Scrubber #1. This change is for informational purposes only and does not affect any license conditions or licensed facility emissions.

# **III. Transfer Requirements**

#### A. Title, Right, or Interest

In their application, ICS submitted copies of property deeds transferring ownership of ICS to ABB. The parties have provided sufficient evidence of title, right, or interest in the facility to allow the transfer of the facility's licenses.

### B. Technical Capacity and Intent

ABB's acquisition of the facility is not expected to result in any significant change in the employees that currently operate the equipment, facilities, and conduct other activities. The facility's regulatory history with the Department demonstrates that the environmental personnel are competent in air pollution control. The information submitted in the application provides sufficient evidence

that ICS continues to have the technical capacity and intent to comply with their air emission license after being acquired by ABB.

#### **ORDER**

Based on the above Findings and subject to conditions listed below, the Department concludes that the emissions from this source:

- will receive Best Practical Treatment,
- will not violate applicable emission standards, and
- will not violate applicable ambient air quality standards in conjunction with emissions from other sources.

The correction of exhaust and control points for Line 2 does not require any additional conditions to be added to the license. Therefore, the Department hereby grants Air Emission License Amendment A-152-71-M-M/T subject to the conditions found in Air Emission License A-152-71-K-R/A.

Based on the above, the Department also concludes that the applicant for the air emission license transfer has the capacity to satisfy all applicable statutory criteria and hereby APPROVES the transfer of Air Emission License A-152-71-K-R/A, from General Electric Company to ABB Inc., subject to all conditions attached to it.
