**FINDINGS OF FACT**

After review of the air emissions license amendment application, staff investigation reports and other documents in the applicant's file in the Bureau of Air Quality, pursuant to 38 Maine Revised Statutes Annotated (M.R.S.A.), §344 and §590, the Maine Department of Environmental Protection (Department) finds the following facts:

**I. REGISTRATION**

**A. Introduction**

Maritimes & Northeast Pipeline, L.L.C. (M&N) was issued Air Emission License A-744-71-K-R on March 17, 2015 permitting the operation of emission sources associated with their natural gas compressor station.

M&N has requested a minor revision to their license in order to correct a typographical error in the Findings of Fact.

The equipment addressed in this license is located at 751 Track Rd, Baileyville, Maine.

**B. Revision Description**

In the processing of the renewal licenses for M&N's Baileyville and Richmond facilities, A-744-71-K-R and A-745-71-J-R respectively, the fee tables in the Finding of Fact were inadvertently transposed, meaning the fee table for Baileyville appeared in the Richmond license and the fee table for Richmond appeared in the Baileyville license. This amendment is intended to correct that error.

**C. Application Classification**

This amendment addresses a typographical error only and does not represent any change in equipment or permitted emissions. Therefore, this amendment is determined to be a minor revision and has been processed as such.

D. Annual Emissions

M&N shall be restricted to the following annual emissions, based on a 12 month rolling total. The tons per year limits were calculated based on the following:

- Turbines #1 and #2 emission limits were calculated based on ambient temperature data indicating 275 hours per year of operation at ambient temperatures less than or equal to 0°F; 2 hours per year of operation at ambient temperatures less than or equal to -20 °F.
- 8,760 hours per year of operation on Turbines #1 and #2 including 65 startup and shutdown events per year.
- 100 hours/year operation of Generator #1
- 8,760 hours/year operation of Boiler #1
