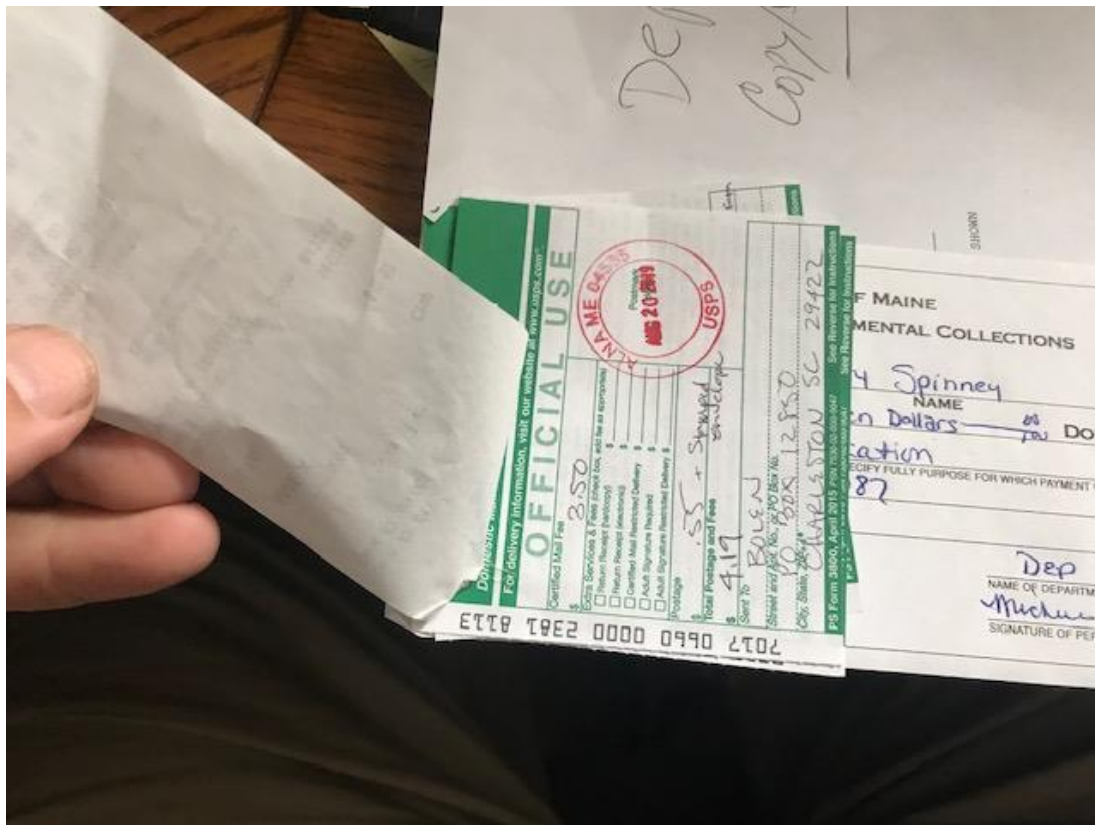

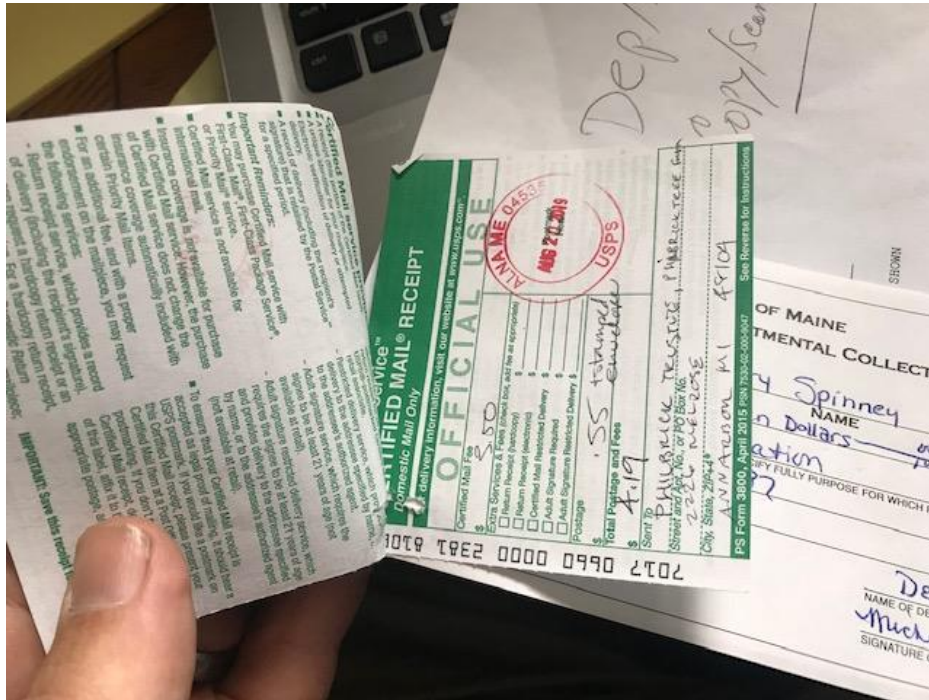

Please take notice that Jeff Spinney, 126 Golden Ridge Road, Alna, ME 04535, 207-227-9017 is intending to file a Natural Resources Protection Act permit application with the Maine Department of Environmental Protection pursuant to the provisions of 38 M.R.S.A. §§ 480-A through 492-BB on or about 8/20/19.

The application is for deck and boat ramp repair work in channelized zone at the following location: 126 Golden Ridge Road.

A request for a public hearing or a request that the Board of Environmental Protection assume jurisdiction over this application must be received by the Department, in writing, no later than 30 days after the application is filed by the Department, for processing. A public hearing may or may not be held at the discretion of the Commissioner or Board of Environmental Protection. Public comment on the application will be accepted throughout the processing of the application.

For Federally licensed, permitted, or bonded activities in the Coastal Zone, review of this application shall also constitute the State's consistency review in accordance with the Maine Coastal Program pursuant to Section 307 of the federal Coastal Zone Management Act, 16 U.S.C. § 1456.

The application will be filed for public inspection at the Department's Environmental Engineering office in Augusta during normal working hours. A copy of the application may also be seen at the municipal offices in Alna, Maine.
