

#### Section 11. PUBLIC NOTICE

This application complies with the MDEP Rules (Chapter 2, Sections 13 and 14 of the Code of Maine Rules). The requisite notifications have been issued and public meetings, in which the Applicant has participated, are discussed and documented in this section.

#### 11.1. PUBLIC INFORMATION MEETINGS AND NOTICES

The Applicant has held five separate MDEP-compliant public information meetings since December 2019.

A Public Informational Meeting was held on December 19, 2019, at the Columbia Town Hall. The Applicant presented background information on the Project, information on the Project's impacts to environmental resources, answered questions about the Project, and discussed the Project with abutters and other interested parties and members of the public. Copies of the MDEP's *Public Participation in the Licensing Process* and the required handout listing the state, local, and federal licenses necessary for the Project, and detailing its expected environmental impacts, were readily available at the meeting.

A copy of the *Public Notice of Informational Meeting* was sent via certified mail to Project participants and abutters. Public notice of the meeting was published in the *County Wide* newspaper on December 3, 2019, and in the *Machias Valley News Observer* on December 11, 2019. Approximately 59 people attended the Project's Public Information meeting. Presentation materials from this meeting can be found online at

www.downeastwindfarm.com/december2019 publicmeeting.

Two additional Public Informational Meetings were held on February 5 and February 6, 2020, at the Columbia Town Hall, to provide another opportunity for interested residents to learn about the Project. The Applicant presented updated information on the Project, information on impacts to environmental resources, economic aspects, safety issues, and viewshed analyses. Presenters answered questions about the Project, and discussed the Project with landowners, abutters, and other interested parties and members of the public. Copies of the MDEP's *Public Participation in the Licensing Process* and the required handout listing the state, local and federal licenses necessary for the project and detailing its expected environmental impacts were readily available and circulated at both meetings.

A copy of the *Public Notice of Informational Meeting* for the February 2020 meetings was sent via certified mail to Project participants and abutters. It was also sent to other area residents via first class mail. Public notice of the meeting was published in the *County Wide* newspaper on January 28, 2020 and in the *Machias Valley News Observer* on January 22, 2020. Approximately 55 people attended the Project's Public Information Meeting on February 5, 2020 and 7 people attended the meeting on February 6, 2020, which was held during a snowstorm. A fourth Public Informational Meeting was held virtually on March 11, 2021 in order to comply with Maine state COVID-19 protocols. The Applicant consulted with MDEP on the format of the meeting prior to scheduling, which included both telephone and online participation options. The Applicant presented background information and updates on the Project, impacts to environmental resources, economics, viewshed, and safety. The Applicant answered questions





about the Project, and discussed the Project with landowners, abutters, and other interested parties and members of the public. Copies of the MDEP's *Public Participation in the Licensing Process* and the required handout listing the state, local, and federal licenses necessary for the project and detailing its expected environmental impacts were posted to the Applicant's website in advance of the meeting.

A copy of the *Public Notice of Informational Meeting* was sent via certified mail to Project participants, abutters, and other stakeholders. Public notice of the meeting was published in the *County Wide* newspaper on February 23, 2021, and in the *Machias Valley News Observer* on March 3, 2021. Approximately 20 people attended the Project's Public Information Meeting by phone or online on March 11, 2021. A full audio recording of the meeting and presentation materials are available online at <a href="https://www.downeastwindfarm.com/march2021\_publicmeeting">www.downeastwindfarm.com/march2021\_publicmeeting</a>.

A fifth and final Public Informational Meeting was held virtually on April 28, 2021 in order to comply with Maine state COVID-19 protocols. The meeting was held in the same MDEP-approved format as the March 11, 2021 meeting, and again included both telephone and online participation options. The Applicant presented background information and updates on the Project, impacts to environmental resources, economics, viewshed, and safety. The Applicant answered questions about the Project, and discussed the Project with landowners, abutters, and other interested parties and members of the public. Copies of the MDEP's *Public Participation in the Licensing Process* and the required handout listing the state, local, and federal licenses necessary for the project and detailing its expected environmental impacts were posted to the Applicant's website in advance of the meeting.

A copy of the *Public Notice of Informational Meeting* was sent via certified mail to Project participants, abutters, and other stakeholders. Public notice of the meeting was published in the *County Wide* newspaper on April 20, 2021 and in the *Machias Valley News Observer* on April 21, 2021.

Approximately 17 people attended the Project's Public Information Meeting by phone or online on April 28, 2021. A Certificate of Mailing and a copy of the notice sent are included in Exhibit 11-1. A full audio recording of the meeting and presentation materials are available online at www.downeastwindfarm.com/april2021\_public\_meeting.

#### Notice of Intent to File

A notice of intent to file (NOI) was sent to Project participants and abutters on March 1, 2021 in combination with the March 11, 2021 Public Meeting Notice. However, the Applicant was not able to complete the application in time to file in early April as anticipated in the first notice. Therefore, an updated notice of intent to file reflecting a new anticipated filing date of April 30, 2021 was mailed to project participants, abutters, and other stakeholders via certified mail on April 22, 2021. A copy of the notice and Certificate of Mailing are included in Exhibit 11-1. A copy of the updated NOI was submitted to the *Machias Valley News Observer* and published on April 28, 2021 and is included in Exhibit 11-1.

#### 11.2. COMMUNITY OUTREACH

Community outreach has been a priority for Downeast Wind since the Project began development in 2013. The Applicant opened a local Project office at Four Corners in Columbia in 2016 and held regular office hours where residents were invited to ask questions and voice concerns. The Applicant has also maintained a website (<u>www.downeastwindfarm.com</u>) that is updated routinely





with Project information and facilitates direct contact with the public. The primary objectives of the Applicant's public outreach activities are effective public communication to facilitate input and feedback about Project particulars and coordination of citizen and community involvement in the development process. Downeast Wind representatives have also done outreach to agencies, which has helped to inform the Project design and other features. This outreach is summarized in Sections 7, 8, 9, and 27.

In addition to the Public Information Meetings described in Section 11.1, Downeast Wind has held 9 open houses and public events since 2016. These events were advertised via direct mailings, local flyers, newsletters, and/or newspaper ads. In addition to providing general Project updates, some of these meetings served more specific purposes. For example, residents were invited to the Project office on February 28, 2017 to provide input on what community benefits they would like to see the Project bring to the local area. There were also two open houses on February 12 and 13, 2020 where residents were invited to view the Project's visual simulations. A list of public outreach events is provided in Table 11.1 below.


