This Third Procedural Order (Order) sets forth the Presiding Officer's decisions with respect to the hearing agenda, objections to and motions to strike testimony, introduction of new exhibits, and other objections submitted by the parties.

1. On October 12, 2021, the deadline set forth in the First Procedural Order in this matter, Intervenor Natural Resource Council of Maine (NRCM), West Forks Group, and Licensees Central Maine Power Company and NECEC Transmission, LLC submitted rebuttal testimony. On October 15, 2021, Intervenor Friends of Boundary Mountains (FBM) submitted a request to cede its cross-examination time to NRCM. Also, on October 15, 2021, Licensees and NRCM submitted objections to rebuttal testimony and NRCM also submitted a proposed revised agenda. On October 18, 2021, NRCM and West Forks submitted proposed exhibits to be presented at the hearing.

### **REQUEST TO CEDE TIME**

2. The request of FBM to cede its allotted time for cross-examination to NRCM is denied.

### **HEARING AGENDA**

3. The hearing agenda will be revised to move the opening statement of Intervenor Industrial Energy Consumer Group to immediately following Licensees' opening statement. All other requests for revisions to the agenda are denied. The agenda as revised will be submitted to the parties along with this Order.
