This Sixth Procedural Order (Order) sets forth the Presiding Officer's decision with respect to certain witness testimony that was offered during this proceeding.

- 1. On November 22, 2021, the Presiding Officer re-opened the license suspension proceeding in the matter of Central Maine Power Company and NECEC Transmission, LLC (Licensees) to hear testimony related to the topics listed in the Fourth Procedural Order. During the daytime portion of the hearing the parties to the proceeding presented testimony and evidence, while the evening portion of the hearing was devoted to receiving testimony from the public. During the portion of the hearing designated for testimony by members of the public, Roger Merchant and Senator Richard Bennett offered testimony as private individuals testifying on their own behalf. The Licensees and Intervenor Industrial Energy Consumers' Group objected to the witnesses being allowed to testify as members of the public.
- 2. After further review, and consideration of the objections, the Presiding Officer has determined that Mr. Merchant and Senator Bennett should not have been allowed to testify on their own behalf during the public portion of the re-opened hearing. Both of these individuals testified during the prior October 19, 2021 hearing session as witnesses for Intervenor Natural Resources Council of Maine. As the public testimony portion of the hearing was restricted to individuals who did not represent a party to the proceeding, witnesses for a party in a prior hearing session in this proceeding should not have provided testimony during the evening session of the hearing. Therefore, the testimony from these two individuals is stricken from the record.
