

26.0 NOTICES

26.1 Introduction

This application complies with the public notice and public information meeting requirements of the MDEP Rules (Chapter 2, Sections 13 and 14 of the Code of Maine Rules). The notifications that have been issued and the public meetings in which CMP has participated are discussed and documented in this section.

26.2 Public Notice

The following notices are required as part of the application process:

1. A Public Notice of Informational Meeting is to be mailed to NECEC abutters and municipalities and, for the unorganized territory, to the appropriate county commissioners, and published in area newspapers;
2. Form B: “Public Notice of Intent to File” is to be sent to NECEC abutters and municipalities and, for the unorganized territory, to the appropriate county commissioners, and published in local newspapers;
3. Form C: “Public Notice Filing and Certification” is to be included in the application.

Public Informational Meetings were held on Tuesday, September 5, 2017 in Windsor, Maine; Wednesday, September 6, 2017, in Lewiston, Maine; and Thursday September 7, 2017 in Bingham, Maine. Approximately 38 members of the public attended the meeting in Windsor, approximately 49 members of the public attended the meeting in Lewiston, and approximately 66 members of the public attended the meeting in Bingham. A summary provided in **Table 26-1** documents significant issues raised at these meetings relevant to licensing criteria, and CMP’s response to these issues.

A list of NECEC abutters, in compliance with §487-A(4), and a list of municipalities to whom notices were sent are provided in **Exhibit 26-1**.

Joint notices including the information required for public notices of informational meetings and public notices of intent to file” were sent via United States Postal Service Certified Mail on August 28, 2017. The filing notice published was a joint MDEP/LUPC notice because the application includes a request, pursuant to 12 M.R.S. § 685-B(1-A)(B-1), that the LUPC certify to the MDEP that the NECEC is an allowed use in the subdistricts in which it is proposed and that the NECEC will comply with applicable LUPC land use standards that are not considered in the MDEP’s review. A copy of the Public Notice of

Informational Meeting as well as proof of publication is provided in **Exhibit 26-2**. The Certified Mail receipts providing evidence of this mailing to abutters, municipalities, and county commissioners is included on a USB flash drive. The Public Notice of the Informational Meeting for each of the meetings was published in the Kennebec Journal and Lewiston Sun Journal on August 28, 2017. The notice was also published in the weekly Wiscasset Newspaper on August 31, 2017.

A completed copy of Form C “Public Notice Filing and Certification” signed by the Applicant attesting that a public informational meeting was noticed and held is provided in **Exhibit 26-3**.

Drivers travel from near and far

OXFORD — The Oxford 250 lures drivers from all-across the country. Take Kodie Conner for example, the 16-year-old from Kannapolis, North Carolina.

At his second Scott's Recreation Oxford 250 presented by Fastway Trailer Products of his short career, Conner was ready for the challenge the Maine race brings.

"Last year, we were talking to a bunch of guys that were saying the Oxford 250 was a really good race to attend," Conner said. "We were not too sure what to expect. Going into the race, I used all the knowledge that I've gotten from racing down south, but it's a totally different ballgame. There are different racers, different driving styles, and the track is so much more different from what we have down there."

At 5 years old, Conner was asked by his father, who also raced, if he wanted to start driving.

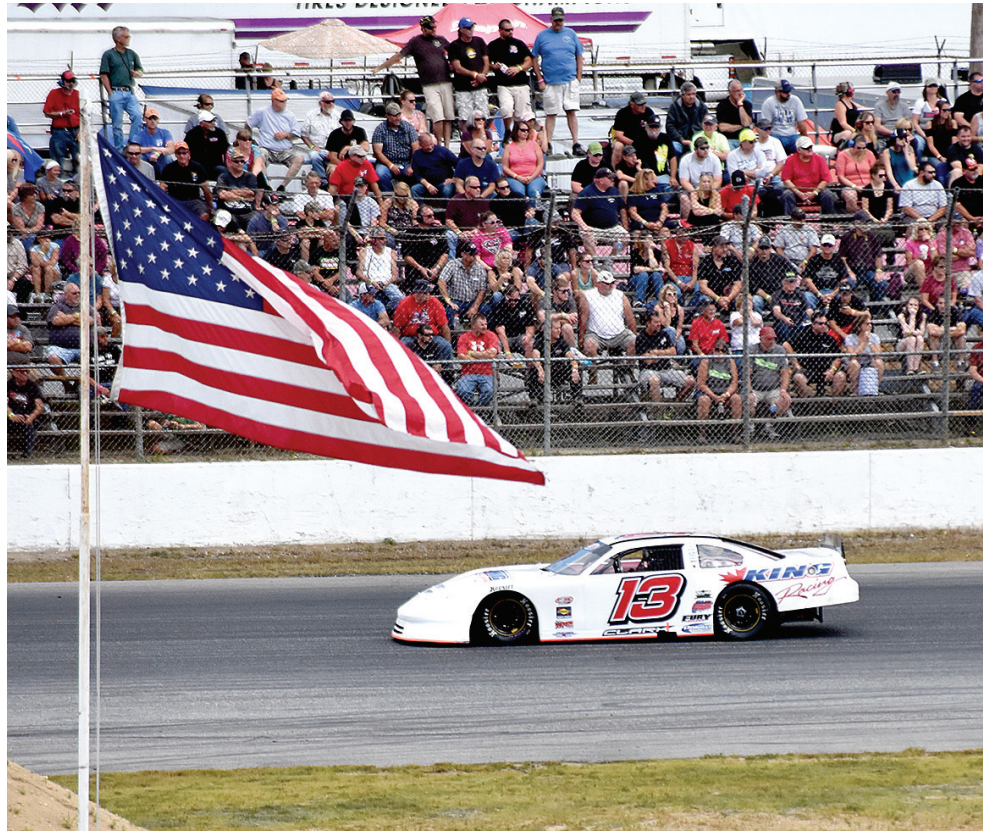
"I said yeah, let's give it a try," Conner said. "I went through a little drivers-development program like drivers ed, and I had my first race at age 5, and since then I've always had a passion for racing."

Conner brought a large team with him to Oxford, including his crew chief who travels from Rhode Island every race to help Conner. Part of that team is his family, which has a deep history of racing. Conner's father, uncle and grandfather all raced cars, helping build the passion that Conner has now for the sport. While the North Carolina driver races often down south, he still makes time for the Oxford 250.

"It's just a really good experience," Conner said.

Cash money

Then there are local drivers like Cassius Clark from Farmington.

The No. 13 car driver with dollar signs in place of each "s" in his name has been driving since he was 17 and said he has raced nine or 10 times at the Oxford 250.

"I grew up with this race," Clark said. "You race for the money, but also the fans. Growing up I watched my dad race and that got me into it."

Clark, like many drivers, travels all

over the country to different races, but he also goes up north to Canada, something that highlights some similarities between crowds there and at the Oxford 250.

"In Canada, the fans love it," Clark said. "Even in weekly races, there are big crowds. A lot of the fans up there are really passionate ... This is a top-five race for me, though."

Something that's different with Oxford is the qualifying method, where drivers are pulled out of a hat into different race heats to qualify.

"You could have a fast car but get drawn in a heat with other fast racers and get stuck," Clark said.

There is no shortage of confidence for Clark, however. When asked what his expectations were for the race Sunday, Clark simply said "win."

Clark's confidence was justified, as he claimed the pole for Sunday's race.

Keeping cool

Last year's champion, Wayne Helliwell Jr., was on hiatus for most of this season due to a diagnosis of Multiple Sclerosis. Helliwell explained that the two biggest triggers of MS are heat and stress, both of which are plentiful in an average race.

After taking a few months off, Helliwell has been making a comeback.

"It's been baby steps," Helliwell said. "I'm starting to feel better, but it's just like anything, I can't predict what's going to happen. It could be half-way through the race where I start to feel bad and pull out, but as of right now I feel good."

To cope with his MS, Helliwell has installed a self-contained air conditioner unit in his car to cool his helmet and the car, "similar to what the Cup series uses."

The aura of the Oxford 250 was something that made Helliwell come back to the race track.

"I like the longevity of it," Helliwell said. "Being 250 laps and the high-strategy of it, you go in the pits multiple times and take new tires throughout the race. I like kind of the prestige and the history of this race, where it started and where it is today."

The Site Location application will include a request, pursuant to 12 M.R.S. § 685-B(1-A)(B-1), that the Land Use Planning Commission (LUPC) certify to the MDEP that the NECEC is an allowed use in the subdistricts in which it is proposed and that the NECEC will comply with applicable LUPC land use standards that are not considered in the MDEP's review.

The Site Location, Natural Resources Protection Act, and Water Quality Certification applications, including the request for LUPC certification, will be filed for public inspection at the MDEP's offices in Augusta and Bangor, and at the LUPC's offices in Augusta and in West Farmington during normal working hours. Requests for the Board of Environmental Protection to assume jurisdiction over the application or requests for a hearing on the application must be submitted to the MDEP in writing no later than 20 days after the application is accepted as complete for processing. A public hearing on the Site Location application may or may not be held at the discretion of the MDEP Commissioner or Board of Environmental Protection. Public comment on the Site Location, Natural Resources Protection Act, and Water Quality Certification applications will be accepted by the MDEP throughout the processing of the applications.

For federally licensed, permitted, or funded activities in the Coastal Zone, review of the Site Location application shall also constitute the State's consistency review in accordance with the Maine Coastal Program pursuant to Section 307 of the federal Coastal Zone Management Act, 16 U.S.C. § 1456.

A request for a LUPC public hearing on the request for certification and/or a petition for leave to intervene in any such hearing must be received by the LUPC in writing no later than 20 days after the request for certification is found by the LUPC to be complete and accepted for processing. The LUPC will consider the degree of public interest when determining whether to hold a public hearing, but the decision whether to hold a hearing is at the LUPC's discretion. If the LUPC holds a public hearing, members of the public also may offer testimony at the hearing without formally intervening in the hearing, and/or may submit written comments until the close of the record. A request or petition that is not timely filed will be denied unless the requestor/petitioner shows good cause for failure to file on time. Filing may be by electronic mail or facsimile if followed by receipt of an original signed document within five working days. Hawke joins four others requesting referendum wording change

Republican group wants insurance stricken from proposed Medicaid expansion question

A local legislator wants to change wording on the referendum this fall calling for expanding Medicaid. Rep. Stephanie Hawke (R-Boothbay Harbor) joined four other House Republican lawmakers and a former Senate president calling for Maine Secretary of State Matt Dunlap to strike the word "insurance" from the ballot question.

The group is challenging referendum Question No. 2's validity by questioning whether Medicaid payments can be called insurance. Hawke and her colleagues describe Medicaid expansion as "taxpayer or government funded health benefits."

Maine Equal Justice Partners is a non-profit advocacy group for low-income residents. The group gathered 67,000 signatures in 2016 to put Question 2 on this November's ballot. In The Portland Press Herald, Executive Director Robyn Merrill defended Medicaid expansion as an insurance program.

"Medicaid doesn't provide cash payments to those who would be covered under the expansion, but instead reimburses health care providers, including Maine hospitals, many of which are struggling to cover the cost of the state's uninsured as charity care."

Referendum Question 2 asks voters, "Do you want Maine to provide health insurance through Medicaid for qualified adults under the age of 65 with incomes at or below 138 percent of the federal poverty line?" Federal guidelines set poverty levels at about \$16,000 for a single person and \$22,000 for a family of two.

Hawke, along with former Maine Republican Party Chairman and former Senate President Rick Bennett and current legislators Rep. Heather Sirocki (R-Scarborough), Assistant House Republican Leader Ellie Espling of New Gloucester, Phylis Ginzler (R-Bridgton) and Paula Sutton (R-Warren) signed the letter objecting to the wording.

The letter outlines perceived problems on "technical" and "practical grounds." The word "insurance" appears in the referendum, but nowhere within the proposed legislation, according to the letter. Hawke spoke briefly during a press conference. The main speakers were Sirocki and Bennett. Hawke responded to a media question on whether she was there as a legislator or citizen. Hawke's response was, "as a concerned citizen."

Hawke was invited by Sirocki to sign the letter and attend the press conference. Hawke didn't know why more Republican legislators didn't attend the signing.

Later in the day, Hawke explained why she attended the news conference and letter-signing ceremony. She said that during her two terms, the legislature has had to "fix" several previous referendum questions, and she has concerns about this fall's Question 2.

"I agree this is simply not insurance under any definition of the law and shouldn't be worded as such in the question," Hawke said.

She has voted at least twice against Medicaid expansion. She described her opposition to Medicaid expansion as being concerned with "too many able-bodied people receiving benefits" and "expansion as being too expensive."

The state's Medicaid expansion would be part of the Affordable Care Act. The federal government would provide \$525 million annually to Maine for the expansion. The state's cost would be approximately \$54 million each year. Even with federal dollars, Hawke believes the program would be a burden on local taxpayers.

"There is no such thing as free money. There are a lot of strings attached to this proposal," she said. "We need to spend more money on the elderly and disabled so I think our state dollars can be better spent on these people rather than expanding welfare to the able-bodied."

Hawke and her fellow Republicans allege the referendum is poorly written and doesn't meet state constitutional standards of being "simple, clear, concise and

direct." She is concerned the question's language would allow wealthy retirees to qualify for Medicaid expansion.

If the wording isn't changed, the Republican group indicated it may challenge the referendum's validity in court.

Currently, 19- and 20-year-olds, individuals with disabilities, the elderly and certain low-income parents qualify for Medicaid which operates

as MaineCare. Maine Equal Justice Partners estimates Medicaid expansion would cover 70,000 additional Mainers. The Secretary of State's office is currently reviewing all public comments on the two statewide referendum questions. The public comment period ends on Sept. 1. Dunlap spokeswoman Kristen Muszynski said there would be no discussion regarding specific concerns about wording during the review period.
