





CLEANING PROCESS
All recovered water will be decanted via the Decanting Approval Plan. The final disposal of wash water, oiled sorbents and materials will be accomplished in accordance with the Disposal Plan. Actual pressure washing, if required will utilize a hot/cold pressure washer with a temperature range up to 220 degrees F and a pressure rating up to 3000 psi.

All personnel involved in the cleaning operation will wear modified PPE level D including rain gear, gloves, rubber boots, and eye protection (face shield and safety glasses). In addition, any personnel working with the arch of an overhead crane or travel lift will wear a hard hat. Once the piece has been determined clean to the accepted standard, the equipment is transferred to the designated "clean" holding area.



Facility Locations & Booming Strategy Status


