## COMMISSION POLICY TO DETERMINE CASING OR LINER & SEALS REQUIRED FOR SPECIALTY WELL APPLICATIONS

When considering a Specialty Well Application, the Commission shall generally follow the guidelines below when determining the minimum amount of casing or liner with seals that will be installed, and if the well casing will need to be grouted in accordance with the Commission's required grouting procedure. The Commission has the authority to deviate from these guidelines to be more or less restrictive when, in their opinion, site specific considerations warrant.

Wells not allowed, Specialty Well Applications will not be considered

Allowed only with approved Specialty Well Application, requires Commission approval at monthly meeting

Allowed only with approved Specialty Well Application, staff approval

Allowed under Chapter 4, paragraph 400.3 and Table 400.1

Does not require a Specialty Well Application

Complies with Rules and only requires 20 feet of casing.

Notes: "Liner & Seals" means approved PVC liners with a Jaswell type seal placed at the bottom of the liner at the depth described above and a second Jaswell type seal to be located inside the well casing. Seals must not leak. "Grouted" means the well shall be constructed with an annular space of not less than a nominal two (2) inches in radius between the outside of the casing and the inside of the borehole. For example, six (6) inch casing requires a borehole at least ten (10) inches in diameter. This space shall be grouted from bottom to top, grout shall be either neat cement or high-solids bentonite manufactured specifically for grouting and sealing water wells, grout shall be placed into the annulus between the borehole and casing in one continuous placement using positive placement (under pressure) from the bottom of the annulus to the top of the well.
