- c. RULEMAKING in 2021 update BLWSO rules for clarity
 - i. Clarify Operator licenses can have two disciplines treatment / distribution
 - 1. VSWS is considered a combined discipline of treatment and distribution
 - 2. A licensee with a license discipline of <u>3T only</u> cannot oversee VSWS designated facility, they would also need a "distribution" discipline to satisfy the treatment and distribution requirement of that system, (i.e. VSWS or 3T3D).

 - 1. Better definition of rules for renewals and TCHs
