1. Review of Minutes

Brian Tarbuck moved to accept Kerry seconded Minutes accepted by vote

2. Budget

Terry provided a brief update, will make available a detailed, itemized budget. Roger will provide system of metrics update at the upcoming May meeting

3. Complaint Procedure

Terry and Deanna led discussion regarding revision of Board rules pertaining to filing complaints against water operators. Substantive elements under scrutiny were anonymity of complainants, order

of investigative steps, and licensing officer's presentation of recommendations. Paul Gauvreau gave additional legal perspective. Wording, order, and format of text were closely reviewed.

Action: Terry will revise the draft procedure integrating recommendations from Deanna and Paul and changes agreed-upon by the Board.

4. Complaint #152128 - Tom Demaso

Complaint brought by Maine Drinking Water Program – Failure to report TC (Total Coliform) samples from two of Mr. Demaso's contracted systems: Fairground Apartments and Pray's Mobile Home Park.

Terry Trott, as investigator of the complaint, noted that:

- The samples were positive;
- The lab did not forward the results to the Drinking Water Program;
- The sample results were received at Mr. Demaso's office while he was out;
- Appropriate action was not immediately taken by Mr. Demaso.

Discussion centered on:

- Problematic system owners
- Operators' responsibilities and best practices
- Drinking Water Program and laboratories' practices and requirements

As a result of her findings, Terry recommended a letter of reprimand for Mr. Demaso: the issue is felt to be too consequential to be dismissed, however given all circumstances suspension or revocation of license would not be appropriate. Paul Gauvreau advised that Mr. Demaso should have thirty days to request an administrative review, if he so chooses.

Mary Bowers moved to issue a letter of reprimand Kerry Smart seconded Motion carried by unanimous vote

Roger outlined Drinking Water Program reorganization.
