Purpose

6 for ME is a quality improvement initiative focused on supporting hospitals to implement at least 6 of the "Ten Steps to Successful Breastfeeding". These Ten Steps are internationally recognized breastfeeding best practices that improve breastfeeding outcomes. The goal is to improve breastfeeding duration and exclusivity for Maine mothers and babies. Maine hospitals have excelled with supporting mothers to initiate breastfeeding. The goal of exclusive breastfeeding for 6 months is elusive and achieving it will require system changes. This program is designed for hospital based health care providers working with pregnant and lactating women. We will explore the latest evidence, the financial aspects of exclusive breastfeeding, and strategies to respond to barriers in implementing these 6 steps.

Program Objectives

- Discuss one key piece of evidence in support of exclusive breastfeeding
- Explain to another provider why implementing evidence-based steps in combination improves breastfeeding outcomes
- Discuss the adverse health and ethical impacts of marketing formula in the birthing hospital
- Discuss challenges faced by providers, and potential strategies to overcome these challenges, when introducing best care practices in a birthing hospital to increase breastfeeding exclusivity and become Baby-Friendly designated
- Strategize development of a state-supported model hospital breastfeeding policy using the work of others as a foundation
- Identify effective counseling and coaching strategies to overcome challenging clinical scenarios when promoting exclusive breastfeeding
