MAINE PHYSICIANS: 2000


Data are from the MAINE COOPERATIVE HEALTH MANPOWER RESOURCE SYSTEM

- In 2000, 2,843 physicians worked in Maine: 2,494 allopathic physicians (MDs) and 349 osteopathic physicians (DOs) - a 60% increase over the number of physicians working in Maine in 1980 (1,771).
- This resulted in a ratio of 1 physician for every 450 Maine residents in 2000, a ratio significantly smaller than in 1980 when there was 1 physician for every 635 residents.
- Although there were more physicians working in Maine in 2000 than in 1980, Maine still had fewer physicians for its population than the US (there was 1 physician for 375 residents nationwide¹).

- Taken together, primary care specialists (physicians specializing in general practice, family practice, obstetrics, gynecology, internal medicine, pediatrics) accounted for 1,227 Maine physicians in 2000 -43% of practicing physicians - a proportion that has been unchanged over the past 20 years. In 1996, the most recent year for which data are available, the national percentage was $40\%^2$.
- The most frequently reported specialty in 2000 was family/general practice accounting for 583 physicians.
- The age composition of Maine's physician population changed during the past 20 years. While the profession as a whole grew by 60%the proportion of physicians at either

end of the age spectrum decreased - by 60% for those younger than 35 years old, and by nearly 40% for those 65 years old and older. The proportion of physicians 45 - 54 years old increased by 75%; all other age groups remained relatively unchanged.



The average age of Maine physicians was 49 years old in 2000, an average that is 2 years older than it was in 1980. Notes: Differences in rates and percentages are statistically significant unless noted, I.e., they could not be accounted for by chance alone.
