## REGISTERED DENTAL HYGIENISTS Data are from the


- ➔ In 2004, there were 739 registered dental hygienists practicing in Maine. This resulted in a statewide ratio of 1 hygienist for every 1,752 residents<sup>1</sup>.
- Cumberland County had a hygienist to population ratio that was significantly lower than the state's ratio; while Somerset and York Counties, had rates that were significantly higher than the statewide ratio.

- ➔ On average, hygienists worked 28 hours a week with nearly all hours (27) spent in direct patient care. Piscataquis County hygienists averaged the most hours with 32 hours a week; Waldo County hygienists averaged the fewest with 24 hours per week.
- → Although 93% of hygienists report they were satisfied overall with their current employment situation, only about 80% said they were happy with the number of hours they worked per week. Twelve percent reported they worked too many hours and

worked too many nours and nearly 6% reported they worked too few.

→ In 1999, more than 75% of hygienists were under 45 years old compared to 64% in 2004. The group between the ages of 45-54 increased from 19% to 28% during the same 5 year period.



→ Eighty hygienists were not currently working in the profession. Nearly 38% (30) of the inactive hygienists were working in another field and not seeking work as a hygienist. Another 23% (18) were not working due to household responsibilities.

→ Other reasons cited for not working were: retired (7), working in another profession and seeking work as a hygienist (7), unemployed (5), and unknown(13).

Notes:A significant difference in ratios mean that the difference between them could not be accounted for by chance alone. <sup>1</sup> Ratio is based on 2002 population estimates, Office of Data, Research, and Vital Statistics.
