Vital Records Processing Times

Copies of Vital Records

- ✓ Walk in customers are normally processed within 10-15 minutes (DRVS reserves the right to mail out the request the next day depending on operational needs).
- ✓ Mail requests take approximately 7-10 business days.
- ✓ Vital Chek orders are processed the next business day (depending on method of delivery).

Registrations

Electronic Birth, Death and Marriage Registrations take approximately 48 hours.

Paper based Birth, Death and Marriage Registrations take approximately 7-10 business days.

Domestic Partnership Registrations take approximately 10-15 business days.

Sub-Registrar appointments take approximately 10-15 business days.

Single Status letters take approximately 10-15 business days (or by appointment).

Temporary Officiant Certificates take approximately 10-15 business days.

State Agency Verifications take approximately 10-15 business days.

Municipal Clerk Verifications take approximately 48 hours.

Corrections

The processing time for any correction type is normally **4-6 weeks**. Corrections submitted for vital records that are maintained in the Database Application for Vital Events (DAVE) system do have a shorter processing time. For consistency reasons, all inquiries should be informed of the **4-6 weeks waiting period**.
