Partners Discussion:

- The DPHIP process has been extended. The development of the new DPHIP will now be taking place from January 2020 to June 2020, with the new DPHIP implemented by July 1st, 2020.
- Partners who attended the meeting discussed their priorities:
 - o **Oxford County Wellness Collaborative:** Substance Use Disorder, obesity, ACEs, as well as addressing isolation/ disconnection/ not feeling valued as a primary root cause.
 - HealthCentric Advisors: Behavioral health integration, trauma informed care, substance
 use disorder and stigma, ACEs vs. chronic health conditions, and helping long term care
 facilities become trauma informed
 - Central Maine Medical Center: Transportation
 - Healthy Androscoggin: Healthy eating, active living, tobacco and substance misuse prevention, and lead poisoning prevention
 - Tri-County Mental Health Services: Integration of practices, access to care, Maine Care expansion – helping people to navigate the system, and becoming an opiate health home
 - o Rumford Hospital: ACEs and behavioral health

- Western Maine Health: Substance Use Disorder, mental health, social determinants of health, and access to care
- o **St. Mary's:** Mental health, substance use, social determinants of health, and lack of transportation
- o **Franklin Memorial Hospital:** Access to care, substance use, Social determinants of health, and physical activity/ nutrition/ weight
