# Welcome and Introduction

Guest Presenter(s): Monica St. Clair, Public Health Analyst, New England HIDTA

**Topic:** New England High Intensity Drug Trafficking Areas & the Heroin Response Strategy Discussion: We would like the tools and resources that a HIDTA designation can bring to a district. How do we make this happen? The Federal grant application must come from Law Enforcement sectors. Money typically funds initiatives and task forces. Aroostook DCC would like to assist partners in any way possibly but not limited to a letter of support. Esther asked if HIDTA had worked with Tribal entities yet. Monica said she had not yet.

Law Enforcement Roundtable Regarding Law Enforcement Needs: US Customs Northbound often sees unintended arrivals. MDEA is very busy and sees intended arrivals of Heroin, but Methamphetamine is more prevalent and rising. Homeland Security Investigations said the equipment to analyze the drugs is extremely expensive. The District Attorney believes that Public health needs to remain focused on prevention since that is where the greatest good could be done, likened to seat belt use. Todd Collins, the District Attorney, explained a pilot program similar to 'drug court' that they have had much success with and is much less taxing on limited resources. (break)
