>PHN successfully recruited and hired 3 new public health nurses for Aroostook District. Anticipated start dates last week of June through beginning of July

\*\* Division of Environmental and Community Health: Drinking Water Program, Health Inspection Program, Radiation Control Program, Environmental and Occupational Health Program

#### Ongoing or upcoming District projects or priority issues:

- Drinking Water is working to address an existing gap in laboratory coverage in Aroostook, particularly relating to environmental testing. Water samples get rejected by HETL with some regularity because they do not arrive within specified timeframes. And it is frequently not feasible to get them there sooner due to transport times and other constraints. Working with a local lab to increase options
- > Drinking Water and Health Inspections will be conducting a joint inspection of a considerably remote North Woods sporting camp in the coming week
- > Search has begun to find a drinking water engineer to fill anticipated vacancy post retirement. The position may or may not be physically located in Aroostook going forward
- ➤ Partnered with Aroostook EMA to conduct focus groups with District stakeholders regarding Extreme Temperature planning

http://www.maine.gov/dhhs/boh/olph/lphd/index.shtml This quarter, the District Coordinating Council (DCC) met on April 27 in-person (19 attendees, low turnout for us) where we heard updates from our district Field Epidemiologist, PHN Supervisor, SCC Representative, workgroup Chairs, Maine CDC Oral Health, and meeting attendees. Matt L'Italien from Somerset Public Health brought copies of the new Maine Prevention Network (MPN) Contract strategies for their work in the district, and discussed adding the Advisory Board required in their contract as a new committee of the DCC. Maija Dyke and Courtney Roderick from Healthy Living for ME® then presented on the new Rural Community Health Improvement Partnership Grant (R-CHIP) and Project to plan for better meeting and coordinating health-related social needs in the district. KCEMA highlighted CPR training now available to schedule through their office.

Ongoing or upcoming projects or priority issues: Avian Influenza; Browntail Moth; DCC membership updates; District Oral Health Profile; Community Health Improvement Plan information and support; new Maine Prevention Network contract implementation consultation; PPE and testing supplies navigation; vaccination clinic, appointment, and transportation assistance; assistance for and connection to organizations providing basic needs and resources; PFAS and lead testing and remediation assistance. Harm Reduction capacity building, and Naloxone distribution support. Increasing housing and utility needs.

**Progress with District Public Health Improvement Plan (DPHIP):** Activities planned for completion during the quarter and whether activities are able to be completed on schedule

- ▶ Use Central District Public Health Unit updates to communicate important information to DCC, LHOs, chief municipal officials, and partners -- ongoing task.

#### Successes achieved

▶ The ACEs-Resilience (now PCEs) Workgroup members are working on school and community supports for trauma and recovery, evaluating available tools, and collaborating on training

#### Barriers encountered

- Large amount of turnover in staffing at many organizations.
- ▶ End of financial supports due to federal funding running out and end of declared emergency in May

**Structural and Operational changes, including updates in membership**: Updating Workgroup charges and membership for 2023; considering addition of Maine Prevention Network (MPN) Contract Advisory Board

In-district or multi-district collaborations: Rural Community Health Improvement Partnership (R-CHIP) grant awarded to Spectrum Generations; COVID-19 and Influenza vaccination and testing information and assistance; COVID-19 response and prevention/basic needs assistance for organizations serving vulnerable populations; EMS service and non-profit organization testing assistance; transportation assistance; HRSA grant collaborations; Avian Influenza, PFAS, rabies, and browntail moth information and workshops.

Other topics of interest for SCC members: Pressing district needs right now for affordable housing, including recovery/supported housing, heating/utility assistance, and transportation services; along with respiratory illness prevention and supports for essential workers and their families.

Brief review of decisions and outcomes from Executive Committee and DCC meetings held since last SCC meeting:

#### January:

CDPHC met on January 20th,2023 with thirty-eight participants. **Dr. Brendan Prast, Marin Johnson**, and **Dr. Christina Holt** represented the **Project ECHO** team of **MaineHealth**, presenting a 15-minute-long pre-recorded presentation by **Dr. Nadi Nina Kaonga**, PGY-4, MMC Dept. of Obstetrics and Gynecology, PGY-4, addressing maternal, newborn and child health concerns specifically highlighting the lived circumstances of immigrants and BIPOC persons, and its impact on pregnancy-related health, the importance of cultural sensitivity, and the role of the Community Health Workers (CHWs). **Grace Lapika**, a Community Health Worker, followed up with a case-study of an immigrant to Maine's journey, and the challenges she faces regarding health for herself and her family- with a focus on the critical role of Community Health Workers in addressing these.

#### March:

The CDPHC met on March 17<sup>th</sup>, 2023 with thirty-two participants. Our scheduled speaker, **Catholic Charities' State Refugee Health Coordinator**, **Danielle Rodriquez** did not attend the meeting, and so the time was used for partner updates and then an early adjournment. **Emilee Winn Caradonna** has accepted a role of Public Health Educator for York within Maine CDC, and was thanked for her many years of service as Council Coordinator. **Leesah Patt** was introduced as Cumberland District Public Health Educator with Maine CDC, and will work to support the Maine CDC Public Health Unit, CDPHC, and external partners, on a range of public health issues.

#### May:

CDPHC met on May 19<sup>th</sup>, 2023 with forty participants. Recent graduates of the **Hanley Center for Health Leadership** XVI cohort presented a final project, that focused on increasing access to doula care, for better birthing outcomes and greater health equity in Maine. Group project participants were: **Christina Booth** (Stephens Memorial Hospital), **Kristine Jenkins** (Maine CDC), **Dr. Grace Price** (Maine Medical Center), **Jennifer Patterson** (Maine DHHS/MaineCare), and **Lauren Stevens** (Wabanaki Public Health). **Leesah Patt**, Public Health Educator, presented a working document of the Maine CDC organizational structure, as part of what will be on-going efforts to illustrate and explain the State public health infrastructure, and will be incorporated into our periodic CDPHC new member (and others) orientation presentations. **Alfredo Vergara** reported that Portland Public Health has completed health screenings at the Expo with approximately 309 people receiving screenings. 159 people have been vaccinated, with a total of 336 vaccines administered.

#### The next CDPHC meeting is July 21, 2023 from 10am-2pm, likely hybrid, location tbd

#### Ongoing or upcoming projects or priority issues:

-CDPHC working group established on public health threats related to housing crisis in Cumberland District created a position paper, which was approved at the January meeting.

- At 5/19 meeting, it was suggested that the CDPHC establish a data sub-group, based on input shared by stakeholders during the Local Public Health Systems Assessment (final report forthcoming)

#### Maine CDC Cumberland Public Health Unit Updates:

- -Public Health Educator for Cumberland District, Leesah Patt joined the public health unit on 2/22/23
- -The MeCDC Cumberland District Public Health Unit toured the new Homeless Services Center in Portland on 3/27. 7 members of the PHU attended, including staff from Infectious Disease Division, Drinking Water Program, Public Health Nursing, the Disease Intervention Specialist, the District Liaison, and Public Health Educator
- -Public Health Nursing has completed childhood catch-up vaccination clinics in Brunswick; have continued Maternal Child Health visits; responded to TB cases, including one active case amongst unhoused youth; and provided Varicella vaccinations at the Cumberland County Jail, in response to a confirmed case amongst the incarcerated population.
- -Health Inspections will have 6 inspectors, plus 2 administrators, and the DL, present at the 2023 Villain Arts Conference in Portland on 6/16. Nearly 200 tattoo artists will undergo inspections with the Maine CDC team at the event.

#### Structural and Operational changes, including updates in membership:

New CDPHC members **Alfredo Vergara**, **Barbara Hanley**, and **Andrew Volkers** were added in March. **Andrew Volkers** joined the Executive Committee in May, and **Naomi Schucker** stepped down.

#### In-district or multi-district collaborations:

- -Maine CDC convened a stakeholder group to assist Maine Immigrant Rights Coalition with organizing health screenings for the 72 people staying at the shelter they run at the Portland Salvation Army. Mercy Hospital will conduct the screenings, assisted by Dr. Heidi Larson, and with supplies from MaineHealth.
- -Initial work for the next round of the Maine Shared Community Health Needs Assessment has begun

#### Other topics of interest for SCC members:

Nearly 800 persons housed in hotels as emergency shelter in greater Portland area hotels are facing eviction as of June 30<sup>th</sup>.

- The April 11<sup>th</sup>, Midcoast Public Health Council (MPHC) meeting featured a presentation by Melissa Fochesato, who gave an overview of the Maine Prevention Network's (MPN) plan for the Midcoast District. Our second presentation was from Karyn Butts, Manager of Maine CDC's Childhood Lead Poisoning Prevention Unit. Karyn shared data that showed increased pediatric lead screening and testing in the District attributable, in part, to a collaboration by the Council's Childhood Lead Committee with District hospitals and practice partners.
- The Social Determinants of Health, Access to Care, and Mental Health workgroups within the MPHC were given time to go into breakout rooms and meet with attendees, give updates on goals and objectives, and discuss other projects and opportunities.

#### Ongoing or upcoming projects or priority issues:

• Maine CDC staff are in-process of completing the Local Public Health System Assessment (LPHSA) reports.

#### Progress with District Public Health Improvement Plan:

• Council Committees will continue to meet and work on strategies for Social Determinants of Health, Access to Care, and Mental Health priorities. Goals and objectives for the priorities were approved at the November 15, 2022, MPHC meeting.

#### Structural and operational changes, including updates in membership:

- The MPHC Steering Committee reviewed its membership and will be making recommendations for additional members.
- The annual elections process begins each August with the MPHC Steering Committee's membership crosswalk and call for candidates.
