- ➤ Highlight completed activities conducted by Maine Prevention Network Contractor/ Subcontractors during April 2023:
 - Aroostook County Action Program (ACAP) MPN HEAL Coordinator convened 2 School Nutrition
 Workgroup Meetings focused on improving the School Cafeteria Environment. 8 SAU's were
 represented with 6 School Nutrition Staff in attendance. Communication regarding shared
 information and meetings includes Ashland Community School, 4 Presque Isle District schools, all
 Valley Unified Schools, Fort Fairfield Schools, Houlton Schools, Easton Schools, Caribou Schools,
 Mars Hill Schools
 - ACAP MPN HEAL staff developed a system that supports local groups or municipalities to loan out physical activities and nutrition resources needed. This was achieved by creating a lending library resource allowing groups to access resources on loan by ACAP with a QR code system for learning about and requesting the items. One such instance allowed our coordinator to collaborate and support a local group called "Nurture By Nature" which is a group working to fund raise to create a Community Wide Garden in Caribou, Maine.
 - ACAP MPN HEAL coordinator supported 2 Community Wide Baby Showers in collaboration with the WIC Program, as well as, many local heath entities to support best practices for breastfeeding mothers. These were held in Houlton and Presque Isle with a turnout of about 80 attendees combined.

District: Central Date: September 21, 2023

Brief review of decisions and outcomes from Executive Committee and DCC meetings held since last SCC meeting. For agendas and copies of minutes, please see district's website at:

http://www.maine.gov/dhhs/boh/olph/lphd/index.shtml This quarter, the District Coordinating Council (DCC) met on July 27 via Zoom (30 attendees) where we first heard an infectious disease update from our district Field Epidemiologist, with a focus on rabies. Next, Courtney Vannah, Program Manager with the Children's Oral Health Network of Maine, presented the draft District Oral Health Profile and asked for feedback on the draft. We then had a 'First Look' at the newly-available 2022 Local Public Health System Assessment (LPHSA) Results with some comparison of the methods and results from the initial district LPHSA in 2010. Because of time constraints and to see if it was a good alternative, the usual SCC report and member updates/collaboration asks was done in a written memo form for this meeting.

Ongoing or upcoming projects or priority issues: District Health Equity funding, rabies, avian influenza; browntail moth; R-CHIP assistance with readiness and municipal priority assessment, PFAS and lead testing and remediation assistance, increasing housing and utility needs, DCC membership updates; Community Health Improvement Plan information and support; PPE and testing supplies navigation; vaccination clinic, appointment, and transportation assistance; assistance for and connection to organizations providing basic needs and resources. Harm Reduction capacity building and Naloxone distribution support.

Progress with District Public Health Improvement Plan (DPHIP): *Activities planned for completion during the quarter and whether activities are able to be completed on schedule*

- ▶ Use Central District Public Health Unit updates to communicate important information to DCC, LHOs, chief municipal officials, and partners -- ongoing task.
- ▶ Vaccination Coordination Workgroup has met monthly to address district needs and coordinate efforts
- ▶ The PCEs-Resilience Workgroup members are working on school and community supports for trauma and recovery, evaluating available tools, and collaborating on training

Successes achieved

- ▶ District Oral Health Profile completed by Partnership for Children's Oral Health with feedback from DCC Barriers encountered
- ▶ Large amount of turnover in staffing at many organizations, and reduction in staff able to help with collaborative public health efforts
- End of financial supports due to federal funding running out

Structural and Operational changes, including updates in membership: loss of shared Council Coordinator support/contract; considering addition of Maine Prevention Network (MPN) Contract Advisory Board

In-district or multi-district collaborations: Rural Community Health Improvement Partnership (R-CHIP) grant awarded to Spectrum Generations; COVID-19 and Influenza vaccination and testing information and assistance; prevention/basic needs assistance for organizations serving vulnerable populations; EMS service and non-profit organization testing assistance; transportation assistance; HRSA grant collaborations; Avian Influenza, PFAS, rabies, and browntail moth information and workshops.

Other topics of interest for SCC members: Pressing district needs right now for affordable housing, including recovery/supported housing, heating/utility assistance, and transportation services; along with respiratory illness prevention and supports for essential workers and their families.

In addition, this report was prepared about the Maine Prevention Network (MPN) Contract Healthy Eating Active Living (HEAL) work accomplished during this quarter by the Maine CDC/DHHS Obesity Program Manager:

Ongoing or upcoming District projects or priority issues:

➤ Highlight completed activities conducted by Maine Prevention Network Contractor/ Subcontractors during June-August 2023:

- Healthy Communities of the Capital Area (HCCA) MPN Heal staff collaborated with Literacy for ME to
 establish a new StoryWalk program for Farrington Elementary School in Augusta. Ongoing work
 includes promotion and increased awareness of this resource.
- Collectively, Central District MPN HEAL programs have communicated HEAL themed public health messaging on social media. In August. the Central PH HEAL team promoted World Breastfeeding Week, August 1-7, including a focus on Breastfeeding in the Workplace. HCCA had 7 posts that were shared over Facebook and Instagram with a focus on breastfeeding in the workplace that promoted paid time off for breastfeeding, flexible return to work options, and advocacy for breastfeeding in the workplace. These posts reached over 430 users, and one post reached 249 users. SPH had 24 posts across both Facebook and Instagram with a total reach of nearly 1,600 people.
- HCCA MPN HEAL staff updated a guide for Food Pantries and Food Banks in Kennebec County. HCCA
 printed 25 guides that were provided at a tabling event for Community Collaboration and Support.
 The event was well-attended, and all guides were distributed. This guide will be made available on
 HCCA's website. The guide was created in June and July, with plans for continued dissemination
 throughout Kennebec County.
- Somerset Public Health (SPH) MPN staff collaborated with Somerset County school nutrition directors from MSAD 54, MSAD 59, and MSAD 74 to develop a School Nutrition Training. The training was held in August, with approximately 65 members of local school nutrition teams in attendance.
 Presentations at this event included civil rights, kitchen safety, Full Plates Full Potential, and a pizza making demonstration by a local food producer (Maine Grains).
- SPH MPN HEAL staff worked with school nutrition directors from MSAD 54, MSAD 59, and MSAD 74
 to promote availability of summer meal opportunities to students and families in Somerset County.
- The SPH and HCCA MPN program staff (Tobacco, Substance Use, and HEAL) are collectively creating
 and collaborating on presentations to support use the Healthy US Scorecard worksite wellness tool.
 Moving forward the team will approach worksites using a coordinated approach.
- SPH MPN HEAL staff are collaborating with the Village Partnership Initiative Study, to review a draft plan (Skowhegan Trail Master Plan) and discuss opportunities to identify strategies that will make Skowhegan's village more welcoming and safer for pedestrians and bikes.

- DPH attended the Maine Tattoo Convention, and shadowed HIP on a day of field inspections, in order to have a better, hands-on understanding of inspections work.

In-district or multi-district collaborations:

- Cumberland District Vaccination Coordination meetings, with DPH, MIP, PHN, healthcare providers, and community partners, which were paused for the summer, began again on September 6th.
- Cumberland District Liaison participates in the Maine CDC Hepatitis A Working Group, Domain 1 accreditation group, MSCHNA Community Engagement committee.
- District Liaison partnered with City of Portland Department of Health to secure funding from the Office of Population Health Equity to provide centralized health screenings for asylum seekers.

September 6th was the first full day of operations for this, at the CoP's Community Clinic. On the first day, 10 patients were screened, and 9 HIV/Syphilis point of care tests were administered. Seven flu vaccines were administered, and two Tdaps. All patients were referred to GPH (FQHC) for non-urgent consults and/or follow-ups, and urgent care cases were connected to local healthcare partners for immediate follow-up.

- > PHN, MIP, and DL are working to address provider questions around how adults can access free Flu vaccine, if they are uninsured.

Ongoing or upcoming District projects or priority issues:

- As of 8/23/23 Cumberland County has had 17 positive rabid animals identified out of 51 total across the state. Raccoons account for most of the positive results (11), followed by skunks (4), bats (1), and woodchucks (1). In 2022, Maine HETL only had 35 positive rabid animals for the entire year (6 of which were in Cumberland Co.). Most of Cumberland Co.'s positive animals were found atypically earlier in the year.
- ➤ Hepatitis A cases have been on a significant upswing in high risk populations and most recently impacted unhoused individuals in Cumberland District. Cumberland District Field Epi has engaged with internal and external partners to address this.
- > Summer outbreak investigations of note: small cryptosporidiosis outbreak associated with raw milk consumption (Epi worked on that in collaboration with DACF); vibriosis outbreak associated with eating raw oysters at an event (worked with HIP and Dept. of Marine Resources to address).
- ➤ Epi is working with the Foodborne Epi and Liz Lamere, Maine CDC Epidemic Intelligence Surveillance officer, to publish a report on the pseudomonas outbreak at an indoor pool in Cumberland District, in the CDC's Morbidity and Mortality Weekly Report. Cumberland District field epi also submitted an abstract with the Vaccine Preventable Diseases epi to the NorthEast Epidemiology Conference in November that was accepted for an oral presentation
- Cumberland District Disease Intervention Specialist reports continued rises in STI rates.
- Congenital syphilis cases are up, and there has been a 21% increase in syphilis among young women, with 5 cases. Cumberland DIS to call for continued education for the public and providers to include syphilis testing in routine health exams, especially for pregnant people.
- The state is hiring 2 additional DIS, which will bring the team up to 5 for the entire state.
- ▶ 8 different boil water orders have been issued in towns in Cumberland County since 5/31/23 to present, as a result of presence of E. Coli

Ongoing or upcoming District projects or priority issues:

- PHN covering Cumberland District are now a 317 vaccine provider
 - > PHN Vaccine Coordinator, Matthew Simpson, will attend the TB Intensive Workshop at Rutgers University in October
 - PHN has cooperated with CoP PH in responding to Hep A outbreaks in the Cumberland County jail and encampments in Portland. PHN provided a large portion of the state's Hep A vaccine stock to CoP for their vaccination efforts.
 - > PHN in Cumberland District is not planning to provide Adult Flu or Covid-19 vaccinations, but rather will focus on primary vaccines
 - PHN will vaccinate 21 asylum-seeking children staying at the Family Promise Shelter
 - > PHN in Cumberland is anticipating vaccination asks from Freeport, Brunswick, and the Lakes Region as school begins
 - A PHN Supervisor for southern Maine had been identified, but had to ultimately decline the position. Candidates for the position are currently being interviewed, and Shannon Craig-McDaniels will continue covering the area of responsibility (along with her other districts), until a new Supervisor is in place.

Ongoing or upcoming District projects or priority issues:

- Longtime Cumberland District Health Inspector, Joel Demers, has taken the position of Health Inspection Supervisor.
- Two Heat Advisories, provided by Division of Environmental and Community Health, along with information on area cooling centers, were distributed by DPH to local partners in August.
- Cumberland District Health Inspectors have responded to cases of Vibriosis, and scombroid poisoning (associated with ingestion of raw fish and exposure to salt and/or brackish water, and ingestion of tuna, respectively).
- > Inspections team in Cumberland are receiving many complaints about sanitation in hotels.
- > Seasonal inspections are on-going, with Cumberland District inspection preparing for Cumberland fair, and winding up summer camp and seasonal business inspections.
- Cumberland District inspection is providing temporary coverage for inspections in Midcoast
