	Heather Sneff, LHO Coordinator, gave a presentation on data compiled from an LHO survey.	
	Question: Heather, how do LHOs keep track of the types of calls they receive and where/how they refer people once they receive the calls.	
	Answer: LHOs report the results of investigations to their municipal officers, who take any formal action needed to resolve the complaint. Records are kept locally at the municipality. LHOs work with the municipality's code enforcement, plumbing inspection, and the District DL to identify any other resources that may be needed (e.g., DEP, Adult/Child Protective Services, etc).	
	Question: I think your abandoned graphic would be helpful for LHOs. We're working on a resource guide template for ours that others could use - what you designed is the same information we're putting together (just a different format) (who to contact for different issues/resources in the community, etc.)	
	Question: Do you have a focus on local emergency response to health-related events, such as working with the municipal ema officer, on extreme temperature; flooding, etc.? are the LHOs encouraged to sign up for HAN?	
	Answer: Local emergency response may be a part of the LHOs role in coordination with the EMA Director and EMS. As mentioned, LHOs are often the EMA Director or EMS person who are plugged into things like the need to open warming or cooling centers. Rebecca Lincoln with the Maine CDC is working with the Districts and County EMA on extreme temperature plans. Yes- LHOs are encouraged to sign up for the Health Alert Network (HAN)	
	Question: what percentage of LHOs are in a stipend position?	
	Answer: All, as far as Heather knows. All training is free.
