This list is of known products; others may exist and will be included as they are evaluated by the agency.

Products not included on the list may have the proper chemicals for sanitizing. However, they do not have dilution instructions required for use on tanning equipment surfaces. Most over-the-counter sanitizers have too strong a concentration resulting greater than 1000 ppm QT check. Products are tested with pH Hydrion Quat-Chek 1000 and QT-10 for dimethyl benzyl ammonium chloride or n-alkyl dimethyl benzyl and/or n-alkyl dimethyl ethyl ammonium chloride parts per million (ppm).
