




How do I Update my Trading Partner Profile to Receive a HIPAA Version 5010 835 Transaction?

1. Go to the Health PAS-Online portal home page:

2. Login to MIHMS with your trading partner ID and password.





If you do not update your trading partner profile to receive a HIPAA Version 5010 835, the system will automatically send a HIPAA Version 4010 835 regardless of the claim file that was submitted. Starting on July 1, 2012, all trading partners will receive a HIPAA Version 5010 835. MIHMS will no longer process HIPAA Version 4010 transaction files after June 30, 2012.
