

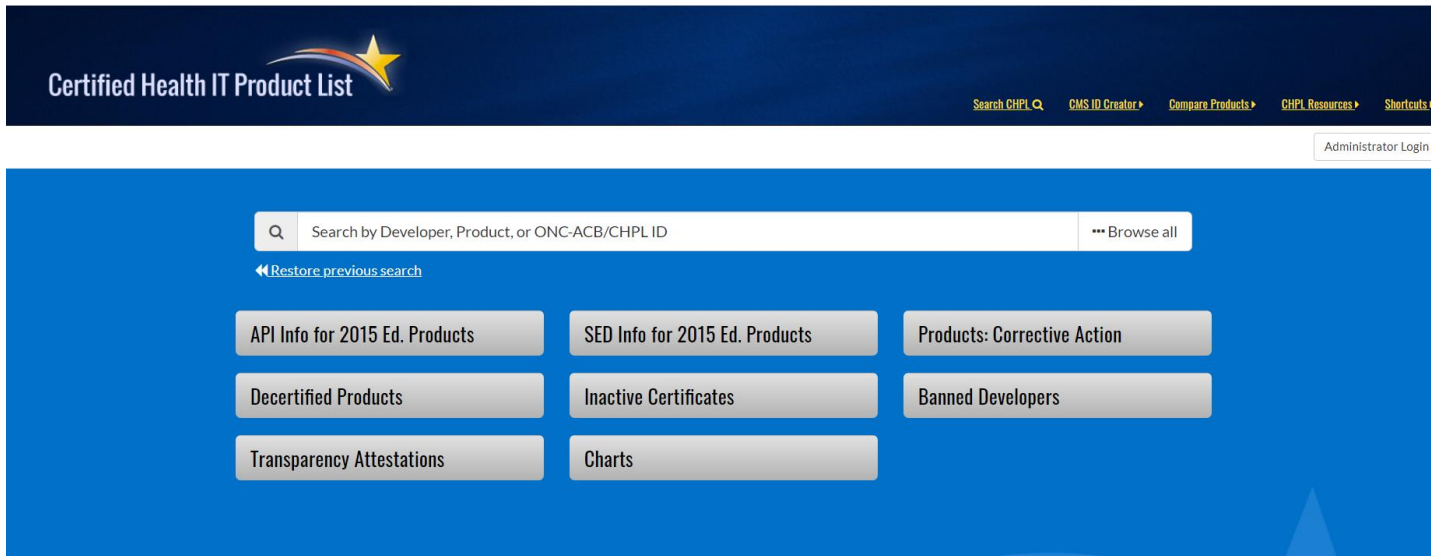
Generating a Certified EHR Technology (CEHRT) ID number through the Certified Health IT Product List (CHPL) site

Please note: Program Year 2020 requires a 2015 edition CEHRT product that supports Stage 3 data.

CMS has updated the Certified Health IT Product List (CHPL) website that supports creation and validation of all certified vendor EHR products. This document will detail the updated workflow to generate a CEHRT ID number.

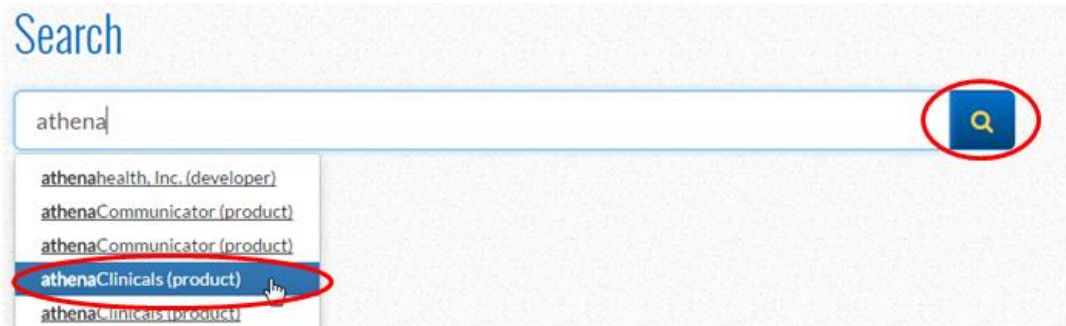
How to Create a CMS EHR Certification ID with a Single CEHRT product

Navigate to the ONC CHPL homepage – <http://chpl.healthit.gov>



Step 1: PRODUCT SEARCH:

- To search for your product, type a keyword such as a developer name (vendor) or product name into the main search area. As you begin typing a drop box appears with results that match the information you've typed. In the example below, we see that there are two developers and four products to choose from.
- **Select one** listing to start your search. We've selected the product – athenaClinicals; then click the looking glass or press enter to search.



- Below are the results that came up for this search. This search brought up 4 products in this example. Note that all 4 products are 2015 edition.

- You can see at a glance a summary of this product’s information listed on the left side of the detail page.

 - Version of product selected
 - Certification Edition – Note: all 2020 products must be 2015 edition
 - Certification Status: should be active
 - ONC-Authorized Certification Body – group that completed the certification
 - ONC-Authorized Testing Laboratory– group that completed the testing for certification
 - Transparency Attestation
 - Mandatory Disclosures URL
 - The details tab opens with the Certification Criteria drop down expanded.

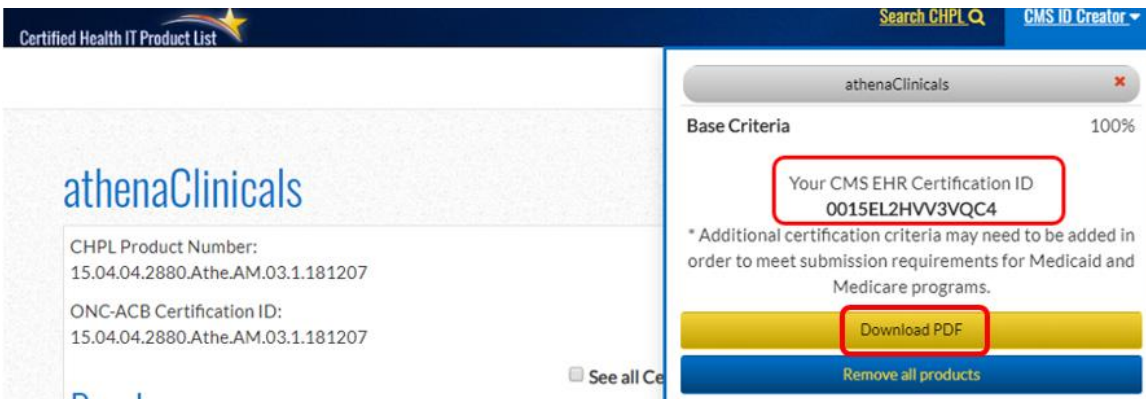

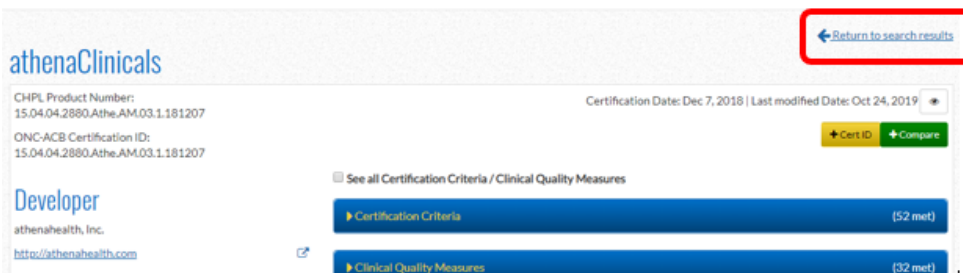
- The screen shot below shows the product has been selected.
- Click the Get 2015 EHR Certification ID (shown below) tab if this is the only product you are using as a CEHRT.



- The screen shot below shows the CMS EHR Certification ID has been generated.
- Click the Download PDF to download a copy of the information for this product. Retain that documentation for the program year.



- If you have selected a product that is not the one you need you can return to the search results to review a different version or product.
- ****Important note**** To navigate back to the search results, click on the “return to search results” in the upper right corner of the page rather than using your browser back button. The back button does not always take you to the previous search.
- You can also click at the upper left corner of the page to return to the home page of the CHPL site.
- Continue with steps 1 and 2 until you have located the correct product and have the documentation for the CMS EHR Certification ID.



How to Create a CMS EHR Certification ID with Multiple CEHRT Products

Follow Steps 1 and 2 above but do not click the Get 2015 EHR Certification ID tab as shown above in Step 2 #9.

You will need to return to the original search page and follow the directions in Step 3 to add multiple products to create a single CMS EHR Certification ID for that collection of products.

STEP 3: SELECT PRODUCT(S)

- If you have multiple products that make up the CEHRT you will need to add them one at a time and then generate a single CEHRT ID.
- Once you have searched and identified a correct product you will add the product to the collection of products used to create your CMS EHR Certification ID.
- Select the yellow “+CertID” button at the right of the product listing that you have determined to be one of the products you need to add it the list of products.

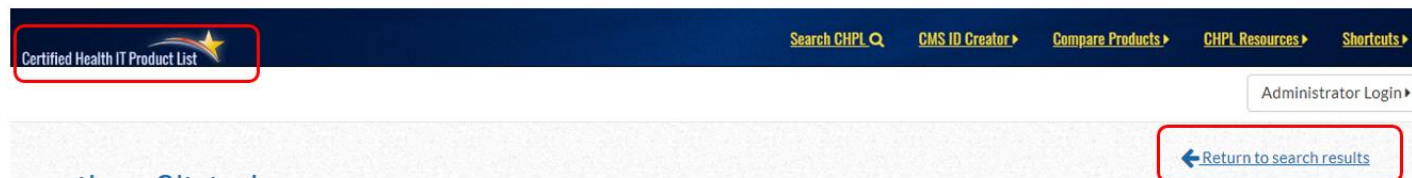

- Once the product is added, the CMS EHR Certification ID widget on the right side of the site will expand showing the product name and status in meeting program requirements. This number is always 100% for a single product but when combining modules and other products they may or may not be at 100% but the total of all will equal 100%.



- To add another product, Click the home page link in the upper left corner to start a new search or the Return to search results.



- Start a search for the next product in the search box as done in step 1.

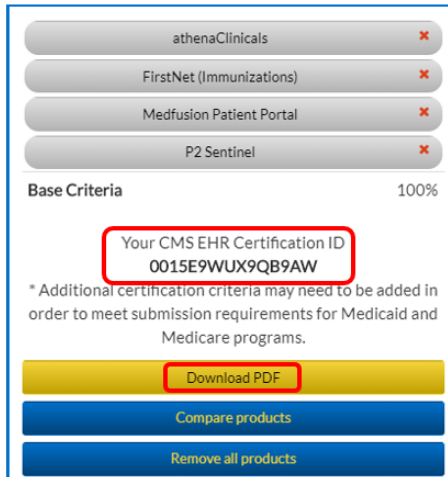

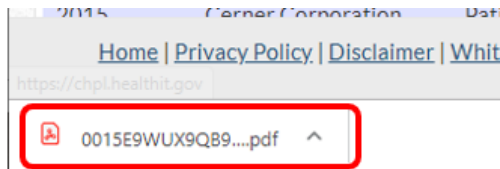

STEP 4: OBTAIN CMS EHR CERTIFICATION ID

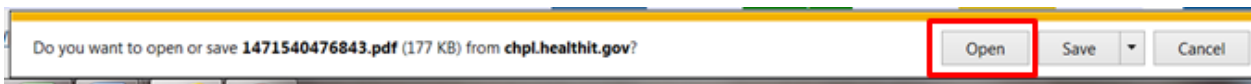
- Once you have entered all the product(s), you will generate a CMS EHR Certification ID that is unique to the products listed.
- Select the yellow “Get 2015 EHR Certification ID” to generate the CMS EHR Certification ID which corresponds to the selected products.
- The widget will generate the Cert ID and give you the opportunity to download a PDF; be sure to download the PDF.



- The CMS EHR Certification ID for these products is: 0015E9WUX9QB9AW.
- The PDF will download to your computer.
- Click the file that shows in the lower left side of your computer.



- The file will either open or give you the option to Open or Save. Click “Open” to view the pdf or “Save” to save for your documentation.



- The file will look the example below.
- It will list all the products that generate the CMS EHR Certification ID. (the example is showing only a portion of what will be on the full file).

- Information for the CQMs will include the version number, the CMS number and the name of the CQM as well as the regulatory number.
- CMS updates the list of CQMs available each year. In the past there were some CQMs available only to Medicaid program participants or Medicare program participants. As of 2019 the available CQMs apply to both programs.
- Because there are changes to the versions we now track which version is being submitted for the CQMs. If you know this information you can make a note on the worksheet when you apply with the Medicaid Program.
