MaineHealth / Henrietta D. Goodall Hospital, Inc. MaineHealth Acquisition of Control of Goodall Hospital Letter of Intent

Dear Ms. Powell:

MaineHealth and Henrietta D. Goodall Hospital, Inc. (HDGH) are requesting a ruling from the Department regarding the applicability of the Certificate of Need Program to MaineHealth's proposed acquisition of control of HDGH.

If the Department determines that this acquisition is subject to Certificate of Need review and approval, MaineHealth and HDGH respectfully request that the Department deem the project to be qualified for the simplified review and approval process as described in the Maine Certificate of Need Act of 2002, 22 M.R.S.A. § 336.

MaineHealth is a non-profit § 501(c) (3) health care corporation headquartered in Portland, Maine. MaineHealth is the ultimate parent entity for various Maine-based hospitals and health care provider organizations, including Southern Maine Medical Center (SMMC). The Department approved MaineHealth's acquisition of control of SMMC in March 2009.

HDGH, a non-profit § 501(c)(3) health care corporation located in Sanford, Maine, provides high quality inpatient and outpatient health care services for the residents of York County.

As a result of the transaction for which MaineHealth is seeking a certificate of need, HDGH will become a member of the MaineHealth system. In this respect, the transaction constitutes an "acquisition of control" within the meaning of 22 M.R.S.A. § 329(1). HDGH will be maintained as a healthcare organization in its current form. Responsibility for the day-to-day operational control of HDGH will reside with the HDG, subject to ultimate oversight by MaineHealth. All property of HDGH pre-closing will remain the property of HDGH post-closing. HDGH will retain its tax-exempt charitable status. Endowment funds of HDGH, including funds held in trust or otherwise for the benefit of HDGH or its subsidiaries will remain assets of HDGH. MaineHealth / Henrietta D. HDGH will have access to shared administrative resources of the MaineHealth system, including purchasing, legal services, financial services, strategic planning, program development, marketing, information services and human resource management. HDGH will also participate in MaineHealth's health benefit and workers' compensation plans, and certain insurance coverage.

There is no capital expenditure requiring a Certificate of Need as described in 22 M.R.S.A. § 329 (3) involved in this transaction. There are no incremental third year operating costs associated with this transaction.

Qualification for Simplified Review

The applicants believe that this transaction qualifies for simplified review since it primarily involves the maintenance of a health facility as defined in 22 M.R.S.A. § 336 (1) and acquisition of control as defined in 22 M.R.S.A. § 336 (3).

Maintenance Project

The proposed transaction addresses the requirements (in italicized text) to qualify for simplified review as a maintenance project in the following manner:

(A) Will result in no or a minimal additional expense to the public or to the health care facility's clients.

MaineHealth and HDGH anticipate that HDGH's becoming a member of MaineHealth will result in no additional expense to the public or to HDGD's clients.

(B) Will be in compliance with other applicable State and local laws and regulations.

HDGH currently operates in compliance with applicable State and local laws and regulations; this transaction will not change that compliance.

(C) Will significantly improve or, in the alternative, not significantly adversely affect the health and welfare of any person currently being served by the health care facility.

MaineHealth and its member organizations consistently have demonstrated their commitment to quality improvement. HDGH will be held to the same expectations as other MaineHealth members. As a member of MaineHealth, HDGH will participate in the development and implementation of MaineHealthinitiated and sponsored health status improvement, clinical integration, and quality improvement initiatives. Acquisition of Control

The proposed transaction addresses the requirements (in italicized text) to qualify for simplified review as an acquisition of control project in the following manner:

(A) Consists of a management agreement or similar arrangement and

HDGH's membership in MaineHealth is similar to the arrangements that are the basis for other local health systems becoming members of MaineHealth that have been reviewed and approved by the Department.

(B) Primarily involves the day-to-day operation of the facility in its current form

The transaction requires no change in the day-to-day operation of HDGH.

(C) is economically feasible in light of its impact on:

(1) The operating budget of the facility and the applicant; and

The transaction results in no net increase in the operating budgets of HDGH or the applicant.

(2) The applicant's ability to operate the facility without increases in the facility's rates beyond those that would otherwise occur absent the acquisition.

The transaction results in no net increase in HDGH's rates beyond those that would otherwise occur absent the transaction.

MaineHealth also seeks to arrange a Technical Assistance meeting to assist the Department in understanding the proposal and to receive guidance from the Department concerning the nature, extent and format of the application, documentary evidence, statistical data and financial data required by the Department to evaluate the application.
