DHHS also announces that an application for a Certificate of Public Advantage (COPA) was received on October 24, 2008. This announcement is made in accordance with the provisions of the Hospital and Health Care Provider Cooperation Act, Title 22 MRSA chapter 405-A.

Applicants: MaineHealth and Webber Hospital Association d/b/a Southern Maine Medical Center (SMMC).

Description of Proposal: SMMC to become a subsidiary corporation of MaineHealth

Review Process: DHHS shall review and evaluate the application in accordance with the standards set forth in Title 22 MRSA chapter 405-A, The Hospital and Health Care Provider Cooperation Act. Any person may provide DHHS with written comments concerning the COPA application within 30 days of this public notice at the address listed below. Intervener status regarding the COPA application may be requested from DHHS at the address listed below within 14 days of this public notice.

DHHS shall issue a preliminary decision at least 5 days prior to issuing a final decision on the COPA application. The preliminary and final decision must be in writing and set forth the basis for the decision to grant or deny the application. The final decision must be issued no less than 40 days and no more than 90 days after the filing of the COPA application on October 24, 2008.
