ISSUE ACTIVATED BY: The referenced proposal requires Certificate of Need (CON) approval as defined in "The Maine Certificate of Need Act of 2002," 22 MRSA §326 et seq., as amended.

I. BACKGROUND:

Ross Manor is a 159-bed long term care facility located in Bangor, Maine and currently operates 83 licensed nursing facility beds, 24 licensed residential care beds for Alzheimer's patients, and 52 assisted living beds. Ross Manor is a joint venture of First Atlantic Corporation and RossCare, Inc., the long-term care operations of Eastern Maine Health Systems. Ross Manor is in good standing with a current license that expires on October 31, 2011.

The Preliminary Analysis by CONU staff, dated April 26, 2011, concluded that this application met all of the CON review criteria.

II. PROJECT DESCRIPTION:

Ross Manor is seeking CON approval to add 20 nursing facility beds to its total nursing facility bed inventory. MaineCare neutrality is being accomplished by the applicant acquiring bed rights from C.A. Dean Hospital in Greenville. The project does not involve new construction or renovations. The cost to acquire the 20 nursing facility beds is estimated to be \$240,000. This cost is not recoverable through MaineCare.
