INSTRUCTIONS

- A. This notification form must accompany all requests for final judicial review and endorsement of Form MH-100.A "Blue Paper" applications where a psychiatric hospital is not initially identified at the time of the certifying examination, the proposed patient has remained at a hospital (*i.e.*, emergency department) following an initial judicial review and endorsement and pursuant to the requirements of 34-B M.R.S. § 3863(3)(D)-(E), and a psychiatric hospital for the proposed patient has since been identified.
- B. This notification form shall be completed by the applicant who originally completed Section 1 of the "Blue Paper" or a representative of the hospital where the patient has been held.
- C. Along with the notification form, the applicant or hospital representative must also provide a copy of the original "Blue Paper" (application, certifying examination, and initial review and endorsement) and on that copy identify in Section 3.B.2 the name of the psychiatric hospital and the least restrictive form of transportation noted in Section 2. The applicant must also provide all immediately preceding "Blue Paper" applications that authorized the proposed patient's detention at a hospital pending the identification of the psychiatric hospital.
- D. Although not required by law, the applicant should be mindful of the preferences of different judicial officers and when possible consider presenting this notification form and attachment to the same judicial officer who performed the initial review and endorsement.
