**CHAPTER NUMBER AND TITLE:** Chapter 42 Changes to Striped Bass Slot Limit

**CONCISE SUMMARY:** On May 18, 2023, DMR adopted an emergency rule to come into compliance with the Atlantic Striped Bass Fishery Management Plan at the Atlantic States Marine Fisheries Commission (ASMFC). DMR is adopting the change to the striped bass slot limit as part of its regular rules. This rule implements a 31-inch maximum size limit in the striped bass recreational fishery. As a result, it is unlawful to take or possess striped bass unless they are between 28-inches and 31-inches, inclusive. This action ensures continued compliance with the ASMFC fishery management plan.

CHAPTER 42: STRIPED BASS

**42.01 Statewide Striped Bass Size Restrictions, Harvest Methods**

**2. Size Restrictions**

It is unlawful to take or possess striped bass which are less than 28 inches long, or ~~equal to or greater than 35~~ 31 inches long, in total length. It is unlawful to possess striped bass unless the fish are whole with head on, and are between 28 inches and 31 inches, inclusive. ~~equal to or greater than 28 inches and less than 35 inches long.~~

**Basis Statement**

On May 18, 2023, DMR adopted an emergency rule to come into compliance with the Atlantic Striped Bass Fishery Management Plan at the Atlantic States Marine Fisheries Commission (ASMFC). DMR is adopting the change to the striped bass slot limit as part of its regular rules. This rule implements a 31-inch maximum size limit in the striped bass recreational fishery. As a result, it is unlawful to take or possess striped bass unless they are between 28-inches and 31-inches, inclusive. This action ensures continued compliance with the ASMFC fishery management plan.

**Summary of Comments**

On June 21, 2023, the rule was posted on DMR’s website. Notice was also published on June 21, 2023, in the five major daily newspapers by the Secretary of State; and electronic messages were sent to individuals who subscribe to DMR’s rulemaking and aquaculture notices. A public hearing was held both in-person and remotely at 4:30 p.m. on July 12, 2023. The in-person hearing was held at DMR’s Augusta office, and the remote component was held via Microsoft Teams. No members of the public attended in-person. The comment period closed July 24, 2023.

**Peter Fallon, July 12, 2023, Public Hearing**

I am also the President of the Maine Association of Charterboat Captains, and while we did not poll our Members about the change in regulation, I can tell you that I heard from a number of folks, other for-hire operators in Maine, following the ASMFC meeting where the emergency action was implemented and everybody that I heard from was in favor of that emergency action and since that time I've not heard from any of our Members who are opposed to the current regulation. So I hope the Advisory Council will make quick work of it and approve.

The American Saltwater Guides Association has always supported the emergency action measure and any action and actions to ensure that we rebuild this stock by 2029 and commend Maine for their strong leadership for conserving this essential stock.

**Sam Adams, Small Point, received via email, July 15, 2023**

I am writing to support the proposed rulemaking regarding Chapter 42.01 Changes to Striped Bass Slot Limit to bring this in line with the ASMFC emergency size limit.

As a lifelong striped bass recreational fisherman in midcoast Maine, and current Registered Maine Tidewater Guide, I have seen this species through dramatic cycles of abundance and decline. Each cycle of decline has been brought about by overfishing of this species along the Atlantic coast, particularly of the large breeding fish disproportionately responsible for maintaining the stock. These so called "trophy" fish are essential to maintaining the overall presence of the species on our coast, yet they have been removed in disproportionate numbers. It is obvious that this is the driver of the current decline in stripers above 31 inches witnessed by recreational fishers all along our coast. My fishing friends and I have noted a sharp decline in larger fish over the last three years in particular, while schoolie-sized fish ranging up to the top of the slot limit have been relatively abundant.

The loss of larger stripers is not Maine's doing alone. By the time these fish arrive in Maine they have been through a gauntlet of bad fishing practices in other states. It pains me to see photographs of large dead breeding-stock stripers piled in the docks of marinas in states to our south and west. But Maine can do something about this loss by protecting medium and large striped bass that enter our waters. This will help stem the decline of the species and help preserve fishing opportunities for Maine citizens and those who come to our shores. Adopting the 31 inch maximum limit will thus promote both environmental and economic benefits.

I urge you to adopt the emergency limit of a maximum of 31 inches for all striped bass, with the slot limit of 28-31 inches for fish taken or possessed.

Hello,

After reviewing a lot of info, I would like to add my Public Comment. As far as the Current Emergency Slot of 28-31". It would be GREAT to see this continue. I think Maine should lead the way in Conservation of Striped Bass and also speak to surrounding states such as Massachusetts to have Gamefish status put on Striped Bass.

As far as the Saco River area being closed, this was an amazingly awesome move by the State of Maine to try and stop the poaching, mishandling and so much more that happens in that area. It may even be worth it for the State to look at Banning the use of Live Alewives/River Herring. I sure hope that Maine continues to put the Striped Bass first.

Also a final thought, the recent event in the news about the Large Gill Net that was Killing lots of striped Bass and Sturgeon should be look at as well. This should NOT be allowed going

forward. It was clear from the pictures and videos that the gill net holes were large and meant to kill larger fish, these practices are unacceptable. Thank you for your time and I hope that Maine will continue to Speak up for striped bass at the ASMFC meetings and not sell out looking for menhaden quota transfers.

*DMR response:* Thank you for your comment and concerns about impacts on striped bass. As regards the specific gill net referenced, early media reports were not well informed by the facts of the situation and have since been corrected. The initial reports of significant numbers of dead striped bass and sturgeon were not accurate.

This proposal is intended to manage the striped bass fishery in compliance with the fishery management plan at the Atlantic States Marine Fisheries Commission.

This proposal would decrease the maximum size limit for striped bass, reducing the sizes of striped bass which can be harvested. This is anticipated to reduce recreational harvest of striped bass in Maine and support rebuilding of the stock.
