EXECUTIVE DIRECTOR'S REPORT

In June 2021 there were 16 shipments of machines and/or associated equipment shipped to or from licensed facilities. On site inspectors completed 653 observations and 28 checklists. There was 1 self-exclusion. There were 6 minor violations that will continue to be monitored from our activity log. There were 1 patron complaint and no formal complaints of potential violations placed on the dashboard.

For the month of June 2021, the Unit has identified an increase of 100.0% in total tax revenue for both facilities versus June 2020. Both facilities closed around March 16, 2020 due to the COVID-19 pandemic. And obviously versus last year, April, May and June will show 100% increases with July openings bringing the numbers back into comparison to the previous year. Year to date the Unit has identified an increase of 127.0% versus last year at the same time.

Oxford reported an 8.3% win for the month of June from slots and 32.6% win from table games. Oxford's payback percentage was 91.7%. Average gross win per machine of \$401.04. Hollywood reported an 8.9% average win for the month of June from slots and 28.5% win from table games. Hollywood's payback percentage was 91.1%. Average gross win per machine was \$226.17.

In July 2021 there were 22 shipments of machines and/or associated equipment shipped to or from licensed facilities. On site inspectors completed 721 observations and 24 checklists. There were 3 self-exclusions. There were 4 minor violations that will continue to be monitored from our activity log. There were no patron complaints and 2 formal complaints of potential violations placed on the dashboard.

For the month of July 2021, the Unit has identified an increase of 164.5% in total tax revenue for both facilities versus July 2020. Year to date the Unit has identified an increase of 134.1% versus last year at the same time.

Oxford reported an 8.3% win for the month of July from slots and 23.0% win from table games. Oxford's payback percentage was 92.0%. Average gross win per machine of \$308.31. Hollywood reported a 9.89% average win for the month of July from slots and 28.2% win from table games. Hollywood's payback percentage was 90.1%. Average gross win per machine was \$264.33.

Director Champion informed the Board that he would be bringing before them, at the September meeting, Resolution 13, which would give the Executive Director the authority to review and approve applications for license renewals of slot machine distributors, table game distributors, and gambling services vendors.

STATE POLICE REPORT

Detective Don Armstrong informed the Board that since his last presentation there have been 52 new license investigations, and 69 renewal application investigations conducted, with 50 licenses still pending. There were 6 TITO thefts; funds were recovered in 4 cases, and 2 cases are still pending. Oxford Police Department had 26 calls for service, and Bangor Police Department had 26 calls for service.
