- 3. Executive Director Report Joe Young
 - a. Membership Update
 - i. State GIS Functions Seat Applications have been approved and are effective 12/12/14 for Maria Jacques and Nate Kane. Glad to have them aboard.
 - ii. GIS Vendors Seat Term has expired for Brian Norris and he will not seek reappointment.

b. Outreach

- i. Listening Sessions
 - Forestry, 12/3/14 The Executive Director met with large landowners to determine imagery needs, approximately 30 people attended. Irving Corp offered \$100 per mile to help obtain the imagery, however, they need higher resolution and probably will not get funds from the USGS for it. USGS may fund up to 50% of cost for acquiring data meeting QL2 specifications.
 - A second meeting is scheduled for January 2015 for a demonstration of how forestry uses the information.
 - Cumberland County, 12/11/14
 - o Presentations on how imagery is used in the area.
 - Harrison Trails focused on actual trails.
 - Next listening session will be held in Bangor on 12/18/14
- ii. Review of LiDAR specifications, how it works and how costs differ.
 - 16,000 sq. miles, \$200 per mile, approx. \$3.2M for budget.
- iii. 2015 Orthoimagery Acquisiition includes, Waldo County and the 2nd third of Penobscot County. Communities indicating an interest in participating are Old Orchard Beach, Cape Elizabeth, City of Portland, York, Dover-Foxcroft, South Portland, Elliot and Raymond.
- iv. USGS proposal for partnership funds to acquire QL2 level LiDAR Was submitted.
- v. Joe Young attended and presented at the Maine Society of Land Surveyors Annual Meeting.
- vi. USGS Liaison MOA was approved by the USGS. Dan Walters can participate in discussions but cannot vote.

 - c. GeoParcels Michael Smith

 - d. Education & Training Cathleen McAnneny, PhD
 - i. Vinton reported that Cathleen is working on ESRI licensing for K-12 educators and the Department of Education will sign. The University of Maine System and Maine Geographic Alliance will provide support to implement it. If there is no commitment for administration of the agreement, Michael Smith suggested contacting Paul Sandlin and Cathy Harrison to see if MEGIS can provide support. Appears that DOE will provide support through the MLTI (Maine Learning Technology Initiative) program at this time.

 - USGS is kicking off a National Hydrographic Data Requirements and Benefits Study
