NEW APPLICANTS: If you are applying and taking the written exam the same day, you must submit a check for the application fee of \$100.00, and a separate check for your 3-year license fee of \$89.00. Applicants must make checks payable to **Treasure State of Maine**. Applicants paying with cash at the date of the exam, must have exact change. Applicants paying by credit card, must contact the Department’s Licensing Division, at 207-287-8000, Monday through Friday, during normal business hours, prior to the exam being administered. If, due to a disability, you need any accommodations for the written exam process, you will need to notify the Licensing Division within 10 days of the exam date.

LEVEL II UPGRADE: Applicants must complete and submit a Whitewater Guide Training Log, to the Licensing Division in Augusta.

INFORMATION REQUIRED: Under MRSA Title 36, section 175 (1), the Department is required to furnish to the State Tax Assessor, a list of all licenses and permits issued annually, that give authority to conduct a profession, trade or business. The permit or license information must include the name, address, Social Security or federal identification number and other identifying information of the licensee.
