NOTICE TO CONTRACTORS

Scaled Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper "Bids for Hot Mix Asphalt Overlay, Pavement Milling, Drainage and Safety Improvements in the city of Waterville and towns of Clinton, Fairfield, Norridgewock, and Oakland" will be received from contractors at the Reception Desk, Maine DOT Building, Child Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on **March 11, 2009** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction or Paving Prequalification or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Location: In Kennebec County, Project No. STP-1573(700)S is located on Baker Street in Clinton, beginning at Route 11/100 and extending northerly 1.160 mi.

In Somerset and Kennebec Counties, Project No. STP-1573(900)S is located on Route 23, beginning at Route 201 in Fairfield and extending easterly 0.630 mi. to 0.19 mi. east of Pishon Ferry Road in Clinton.

In Kennebec County, Project No. STP-1574(600)S is located on Route 23 (Fairfield Street) in Oakland, beginning 0.1 mi south of Greeley Street and extending northerly 0.927 mi. to 0.3 mi. north of the Town Garage Road.

In Kennebec County, Project No. STP-1574(700)S is located on Pleasant Street in Oakland, beginning 0.06 mi. west of Oak Street and extending easterly 0.405 mi. to 0.10 mi. east of Ayer Street.

In Kennebec County, Project No. STP-1575(700)S is located on Oak Street in Waterville, beginning at Main Street and extending easterly 0.427 of a mile to College Avenue.

In Kennebec County, Project No. STP-1583(200)S is located on Route 11, beginning at Route 23 in Oakland and extending northerly 4.367 mi. to 0.01 mi. north of Winter Street in Waterville.

In Somerset County, Project No. STP-1584(300)S is located on Route 139, beginning 0.88 mi. east of Covell Road in Fairfield and extending westerly 4.734 mi. to 0.33 mi. west of Bigelow Hill Road in Norridgewock.

Plans, specifications and bid forms may be seen at the Maine DOT Building in Augusta, Maine. They may be purchased from the Department between the hours of 8:00 a.m. to 4:30 p.m. by cash, credit card (Visa/Mastercard) or check payable to Treasurer, State of Maine sent to Maine Department of Transportation, Attn.: Mailroom, 16 State House Station, Augusta, Maine 04333-0016. They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m. Bid Book \$10 (\$13 by mail), payment in advance, all non-refundable.

Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$80,000 payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.

This Contract is subject to all applicable Federal Laws. This contract is subject to compliance with the Disadvantaged Business Enterprise program requirements as set forth by the Maine Department of Transportation.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", price \$10 [\$13 by mail], and Standard Details, Revision of December 2002, price \$20 [\$25 by mail].
