NOTICE TO CONTRACTORS

Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper "Bids for Crack Sealing in the towns of Caswell, Crystal-Patten, Easton, Fort Fairfield, Weston, Houlton-Littleton, and Bridgewater-Blaine" will be received from contractors at the Reception Desk, Maine DOT Building, Child Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on **April 15, 2009** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a project of similar size and scope or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Description: State project PIN 15961.55.

Location: In Aroostook County: **Section 1** is located on Route 1A, beginning at the junction of Route 1A and Willard Rd (RLM 114.05) and extending northerly 4.76 miles to 0.70 of a mile south of the Caswell-Hamlin T/L (RLM 118.81).

In Aroostook and Penobscot Counties: **Section 2** is located on Route 159, beginning 0.16 of a mile east of River Rd (RLM 2.14) and extending westerly 7.75 miles to 0.04 of a mile east of Pleasant St (RLM 9.89).

In Aroostook County: **Section 3** is located on Conant Rd, beginning at Route 1A (RLM 0.00) and extending westerly 1.77 miles to 0.24 of a mile west of Bangor Rd (RLM 1.77).

In Aroostook County: **Section 4** is located on Route 161, beginning at Route 1A (RLM 0.00) and extending westerly 1.52 miles to 0.62 of a mile west of Hopkins Rd.(RLM 1.52).

In Aroostook County: **Section 5** is located on Route 1, beginning 0.85 of a mile south of Harris Hill Road (RLM 375.90) and extending northerly 2.80 miles to 0.36 of a mile south of Number Nine Rd (RLM 378.70).

In Aroostook County: **Section 6** is located on Route 1, beginning at the Houlton C.U.L. (RLM 405.49) and extending northerly 6.20 miles to 0.30 of a mile north of the Ingraham Rd in Littleton (RLM 411.69).

In Aroostook County: **Section 7** is located on Route 1, beginning at the Snow Rd in Bridgewater (RLM 423.95) and extending northerly 6.10 miles to the Bubar Rd in Blaine (RLM 430.05).

Outline of Work: Crack Sealing and other incidental work.

They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m. Bid Book \$10 (\$13 by mail), payment in advance, all non-refundable.


Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$12,000 payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.

This Contract is subject to all applicable Federal Laws. This contract is subject to compliance with the Disadvantaged Business Enterprise program requirements as set forth by the Maine Department of Transportation.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", price \$10 [\$13 by mail], and Standard Details, Revision of December 2002, price \$20 [\$25 by mail].
