NOTICE TO CONTRACTORS**

Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper "**Bids for Pavement Milling, Hot Mix Asphalt Overlay, Guardrail, Drainage, and Safety Improvements** in the towns of **Madison and Skowhegan**" will be received from contractors at the Reception Desk, Maine DOT Building, Child Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on March 17, 2010 and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction or Paving Project, or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Description: Maine Federal Aid Project Nos. NH-1680(600)E, PIN 16806.00, NH-1680(800)E, PIN 16808.00, & STP-1730(800)X, PIN 17308.00.

Location: In Somerset County, Project No. NH-1680(600)E is located on Route 201, beginning at Russell St.(Commercial St.) and extending northerly 1.861 mi. to 0.091 mi. north of the Skowhegan/Madison town line. In Somerset County, Project No. NH-1680(800)E is located on Route 2, beginning at the Wesserunsett Stream Bridge and extending easterly 4.706 mi. to the Skowhegan/Canaan town line. In Somerset County, Project No. STP-1730(800)X is located on US Rte 201A, beginning 0.08 mi. northerly of Father Rasle Rd and extending northerly 0.97 mi. to 0.05 mi north of Pleasant Street.

Outline of Work: Pavement Milling, Hot Mix Asphalt Overlay, Guardrail, Drainage, Safety Improvements and other incidental work.

They may be purchased from the Department between the hours of 8:00 a.m. to 4:30 p.m. by cash, credit card (Visa/Mastercard) or check payable to Treasurer, State of Maine sent to Maine Department of Transportation, Attn.: Mailroom, 16 State House Station, Augusta, Maine 04333-0016. They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m. Bid Book \$10 (\$13 by mail), payment in advance, all non-refundable.


Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$65,000 payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.


