NOTICE TO CONTRACTORS**

Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper Bids for "Maintenance Surface Treatment Paving in the towns of Acton, Biddeford, Buxton, Dayton, Gorham, Lebanon, Lyman, Scarborough, Standish, Waterboro and Westbrook" will be received from contractors at the Reception Desk, Maine DOT Building, Child Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on **May 20, 2009** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction or Paving Prequalification, or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening.** Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.

Locations:

In York County:

MAP ID 1 is in Acton on Milton Mills Rd, from the New Hampshire state line extending easterly 5.83 mi to Rte 109.

MAP ID 2 is in Lebanon and Acton on Fox Ridge Rd, from Rte 11/202 extending northerly 8.13 mi to the New Hampshire state line.

In York and Cumberland Counties:

MAP ID 3 is in Buxton and Standish on Saco Rd, from the CUL west of Rte 35 extending northerly 3.6 mi to Rte 25.

MAP ID 4 is in Buxton and Gorham on Rte 112, from Rte 22 extending northerly 4.0 mi to Finn Parker Rd.

In Cumberland County:

MAP ID 5 is in Scarborough, Gorham and Westbrook on Saco St, from the CUL north of Rte 22 extending northerly 1.29 mi to the CUL

In York County:

MAP ID 6 is in Waterboro and Lyman on Waterboro Rd, from Rte 4/202 extending easterly 7.67 mi to Rte 35.

MAP ID 7 is in Waterboro on West Rd, from a point 0.8 mi east of Ross Corner Rd extending easterly 5.0 mi to Rte 4/202.

MAP ID 8 is in Lyman, Dayton and Biddeford on South St, from Rte 35 extending easterly 3.17 mi to the CUL 0.46 mi west of River Rd. south of Eleanor Ave.

Total length is 38.70 miles.

They also may be purchased by telephone at (207) 624-3536 between the hours of 8:00 a.m. to 4:30 p.m. Bid Book \$10 [\$13 by mail], payment in advance, all non-refundable.


Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$40,000 payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.

This Contract is subject to all applicable Federal Laws. This contract is subject to compliance with the Disadvantaged Business Enterprise program requirements as set forth by the Maine Department of Transportation.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", price \$10 [\$13 by mail], and Standard Details, Revision of December 2002, price \$20 [\$25 by mail].
