Sealed Bids addressed to the Maine Department of Transportation, Augusta, Maine 04333 and endorsed on the wrapper **Maintenance Surface Treatment Paving** in the towns of **Danforth, New Limerick, Linneus, Silver Ridge, Benedicta, Sherman, and Ludlow** and the townships of **Brookton, Forest, Forest City, T8-R3, and T8-R4** will be received from contractors at the Reception Desk, Maine DOT Building, Child Street, Augusta, Maine, until 11:00 o'clock A.M. (prevailing time) on **April 14, 2010** and at that time and place publicly opened and read. Bids will be accepted from all bidders. The lowest responsive bidder must have completed, or successfully complete, a Highway Construction or Paving Prequalification or project specific prequalification to be considered for the award of this contract. **We now accept electronic bids for those bid packages posted on the bidx.com website. Electronic bids do not have to be accompanied by paper bids. Please note: the Department will accept a facsimile of the bid bond; however, the original bid bond must then be received at the MDOT Contract Section within 72 hours of the bid opening. Until further notice, dual bids (one paper, one electronic) will be accepted, with the paper copy taking precedence.**

Location: In Washington and Aroostook Counties, project is located

Map ID 1 is in New Limerick - New Limerick/Drews Lake Rds, Begin at the Jct of Bangor Rd and New Lemerick Rd, to the Jct of New Lemerick / Drew Lake rd / Station Rd.

Map ID 2 is in Danforth - Rte 169, Beginning .8 miles Westerly of the Danforth / T8 - R4 Town Line, to the Jct of Calis Rd, Depot St, Houlton Rd, Springfield Rd.

Map ID 3 is in Brookton Twp, Forest Twp, Forest city - Forest City Rd, From the Jct of Rt 1 to the, Canadian border

Map ID 4 is in T8 - R3, T8 - R4 - Rte 169, From the Washington C/L line, to the Danforth / T8-R4 town line

Map ID 5 is in Silver Ridge - Pond rd, Begin at the Jct of the Rte 2 and Pond Rd., and extend southwesterly 1 mile.

Map ID 6 is in Benedicta, Sherman - Pond rd, Begin .33 miles northerly of the Jct of Aroostook/Benidicta/Pond Rd., and extend 5.05 miles northerly to the Jct of Rte 11 in Sherman.

Map ID 7 is in New Limerick, Ludlow - French/Ludlow Rds, From the jct of Rte. 2 northerly., to .88 miles easterly of the Houlton/Ludlow town line.

Map ID 8 is in Houlton - Benedicta Rd, Begin .04 miles easterly of the Ludlow rd/Callaghan Rd Jct and, extend .74 miles easterly to the Jct of the Ludlow rd/Stewart rd. (Second section)

Total length is 41.48 miles


Each Bid must be made upon blank forms provided by the Department and must be accompanied by a bid bond at 5% of the bid amount or an official bank check, cashier's check, certified check, certificate of deposit, or United States postal money order in the amount of \$50,000 payable to Treasurer, State of Maine as a Bid guarantee. A Contract Performance Surety Bond and a Contract Payment Surety Bond, each in the amount of 100 percent of the Contract price, will be required of the successful Bidder.

This Contract is subject to all applicable State Laws.

All work shall be governed by "State of Maine, Department of Transportation, Standard Specifications, Revision of December 2002", price \$10 [\$13 by mail], and Standard Details, Revision of December 2002, price \$20 [\$25 by mail].
